ORDINANCE #65

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF HACKENSACK TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON

WHEREAS, certain territory described below is not presently included within the corporate limits of the City of Hackensack; and

WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of Hackensack and is deemed to be urban or suburban in character;

The City Council of Hackensack ordains:

Section 1: Territory Annexed. The corporate limits of the City of Hackensack, Minnesota, are hereby extended to include the unplatted territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the city limits:

Patrick L. and Marlyce A. Fistman property described as follows to-wit: The West 608.75 feet of the Northeast Quarter of the Southeast Quarter (NE 1/4 SE 1/4), Section Nineteen (19), Township One Hundred Forty (140) North, Range Thirty (30) West, Cass County, Minnesota, which lies North of the South 495.00 feet thereof.

Clester S. and Barbara J. Erickson property described as follows to-wit: The Northeast Quarter of the Southeast Quarter (NE 1/4 SE 1/4) of Section Nineteen (19), Township One Hundred Forty (140), Range Thirty (30), less the South 495 feet thereof, and also less the West 608.75 feet thereof.


Section 2. Filing. The city clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of Cass County, the Birch Lake Town Clerk and the Minnesota Municipal Board.

Section 3. Population. The population of the annexed territory is approximately 10.

Section 4. Effective Date of Annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2 and approval by the Minnesota Municipal Board.
