

**ORDINANCE NO. ORD 001-465**

**CITY OF FARMINGTON  
DAKOTA COUNTY, MINNESOTA**

**AN ORDINANCE OF THE CITY OF FARMINGTON,  
ANNEXING CERTAIN PROPERTIES TO THE CITY OF FARMINGTON**

THE CITY COUNCIL OF THE CITY OF FARMINGTON ORDAINS:

SECTION 1. Farmington City Code Section 1-11-2: CHANGES; OFFICIAL MAP,  
(A) Annexations is amended by adding paragraphs 37 to read as follows:

37. The property described below is hereby annexed to the City of Farmington pursuant to MSA section 414.033:

Parcel A: The West 2 acres of the South 6 acres of the South half of the Northwest quarter of the Northwest quarter of Section 32, Township 114, Range 19, EXCEPTING THEREFROM a tract of land described as follows:

Commencing at the Northwest corner of the said West 2 acres of the South 6 acres of the South half of the Northwest quarter of the Northwest quarter of said Section Thirty-two; thence East 170 feet; thence South 60 feet; thence West 170 feet; thence North 60 feet to the place of beginning.

Parcel B: All that part of the Northwest quarter of the Northwest quarter of Section 32, Township 114, Range 19, described as follows: Commencing at the Northwest corner of the South 6 acres of the South half of the Northwest quarter of the Northwest quarter, thence East 170 feet, thence South 60 feet, thence West 170 feet, thence North 60 feet to the place of beginning, according to the Government Survey thereof.

SECTION 2. Effective Date. This ordinance shall be effective immediately upon its passage and publication according to law.
