INTENT TO ANNEX UNDER MINNESOTA STATUTES SECTION 414.031, SUBDIVISION 1(a)

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE
CITY OF MOUNTAIN IRON, MINNESOTA:

1. That this Resolution to annex is hereby initiated pursuant to Minnesota Statutes Section 414.031 Subdivision 1(a).
2. That the boundaries proposed for annexation are all properties not currently located within the City of Mountain Iron and are located in the boundaries as set forth on the map attached hereto, which is incorporated herein by reference.
3. That the names of all parties entitled to notice under Minnesota Statutes Section 414.09 are the Executive Director of Minnesota Planning for the State of Minnesota, the Town of Great Scott, the Town of Wuori and the Saint Louis County Board on behalf of its Unorganized Territory, due to the fact that no City or Township abuts the northern boundary of the affected territory, and no planning agency has jurisdiction over the affected area other than that of Saint Louis County.
4. That all property owners within the affected area also receive notice of this action.


