## AN ORDINANCE ANNEXING LAND OWNED BY ANGIE WALTHER TO THE CITY OF PARK RAPIDS HUBBARD COUNTY, MINNESOTA PURSUANT TO MINNESOTA STATUTES 414.033, SUBD 2(3)

The City Council of the City of Park Rapids, Hubbard County, Minnesota does hereby ordain:

Section 1. Angie Walther has petitioned the City of Park Rapids for annexation of her land as located in Todd Township, Hubbard County, Minnesota, immediately south of the Headwaters Humane Society Animal Shelter, fronting Western Avenue, in the NE ¼ of the SE ¼ of Section 27.

Section 2. Notice was duly given and a hearing was held in conformance with Minnesota Statutes 414.033 Subd. 2b on November 29<sup>th</sup>, 2004.

Section 3. The corporate limits of the City of Park Rapids are hereby extended to include the unplatted land as described on the attachment to this ordinance and the same is hereby annexed to be included within the City of Park Rapids, Minnesota, containing 5.0 acres.

Section 4: The City Clerk is directed to make the statutory filings with the Department of Administration, Municipal Boundary Adjustments, and the affected Hubbard County and Township departments and officers.

Commencing at the Northeast corner of said Northeast Quarter of the Southeast Quarter; thence on an assumed bearing of South 00 degrees 19 minutes 20 seconds West along the East line of said Northeast Quarter of the Southeast Quarter a distance of 934.06 feet to the Southeast corner of the North 934.00 feet of said Northeast Quarter of the Southeast Quarter; thence continuing South 00 degrees 19 minutes 20 seconds West along said East line a distance of 406.67 feet to the Southeast corner of said Northeast Quarter of the Southeast Quarter; thence South 89 degrees 39 minutes 36 seconds West along the South line of said Northeast Quarter of the Southeast Quarter a distance of 535.57 feet; thence North 00 degrees 19 degrees 22 seconds East a distance of 406.41 feet to the South line of said North 934.00 feet of said Northeast Quarter of the Southeast Quarter; thence North 89 degrees 37 minutes 56 seconds East along said South line a distance of 535.57 feet to the point of beginning and there terminating.
