AN ORDINANCE PROVIDING FOR THE ANNEXATION BY PROPERTY OWNER
PETITION BY AMENDING SECTION XII, "ANNEXATION BY ORDINANCE" OF THE
RUSH CITY CODE BY ADDING PART 11.

Section XII. Annexation By Ordinance

Part 11. Petition of Delores L. Mold

Section 1211.01. Delores L. Mold, fee owner and the "Petitioner", petitioned for the inclusion of the following described parcel in the city limits of Rush City under the provisions of Minnesota Statutes 414.033:

That part of the N ½ of the SW 1/4 of Section 15, Township 37, Range 21 West, lying southerly of the north 500 feet and lying westerly of the following described line: Commencing at the center of said Section 15; thence N 89 degrees 1 minute 48 seconds W along the N line of said N ½ of the SW 1/4 590.52 feet to the point of beginning; thence S 19 degrees 44 minutes 3 seconds E to the S line of said N ½ of the SW 1/4 and there terminating.

Section 1211.02. The Petitioner has declared, and it has been confirmed, that the parcel is less than sixty (60) acres in size and is not now served by public sewer facilities and public sewer facilities are not otherwise available.

Section 1211.03. The City Council of Rush City conducted a properly-noticed public hearing to consider the petition on Monday, May 10, 2004, at 7:05 p.m. in the Rush City City Hall at which time and place all persons desiring to be heard were afforded the opportunity.

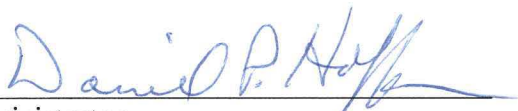
Section 1211.04. There are no residences on the property and the population consists of zero persons.

Section 1211.05. The property abuts the present corporate limits of Rush City.

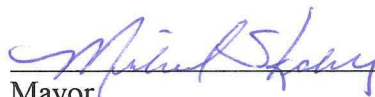
Section 1211.06. Upon adoption of the ordinance amendment, the land described herein shall be annexed to the City of Rush City, a municipal corporation, and be included in the corporate limits thereof as per Minnesota Statutes Section 414.033.

Section 1211.07. Upon adoption, certified copies of the ordinance shall be filed as provided in Minnesota Statutes Chapter 414.

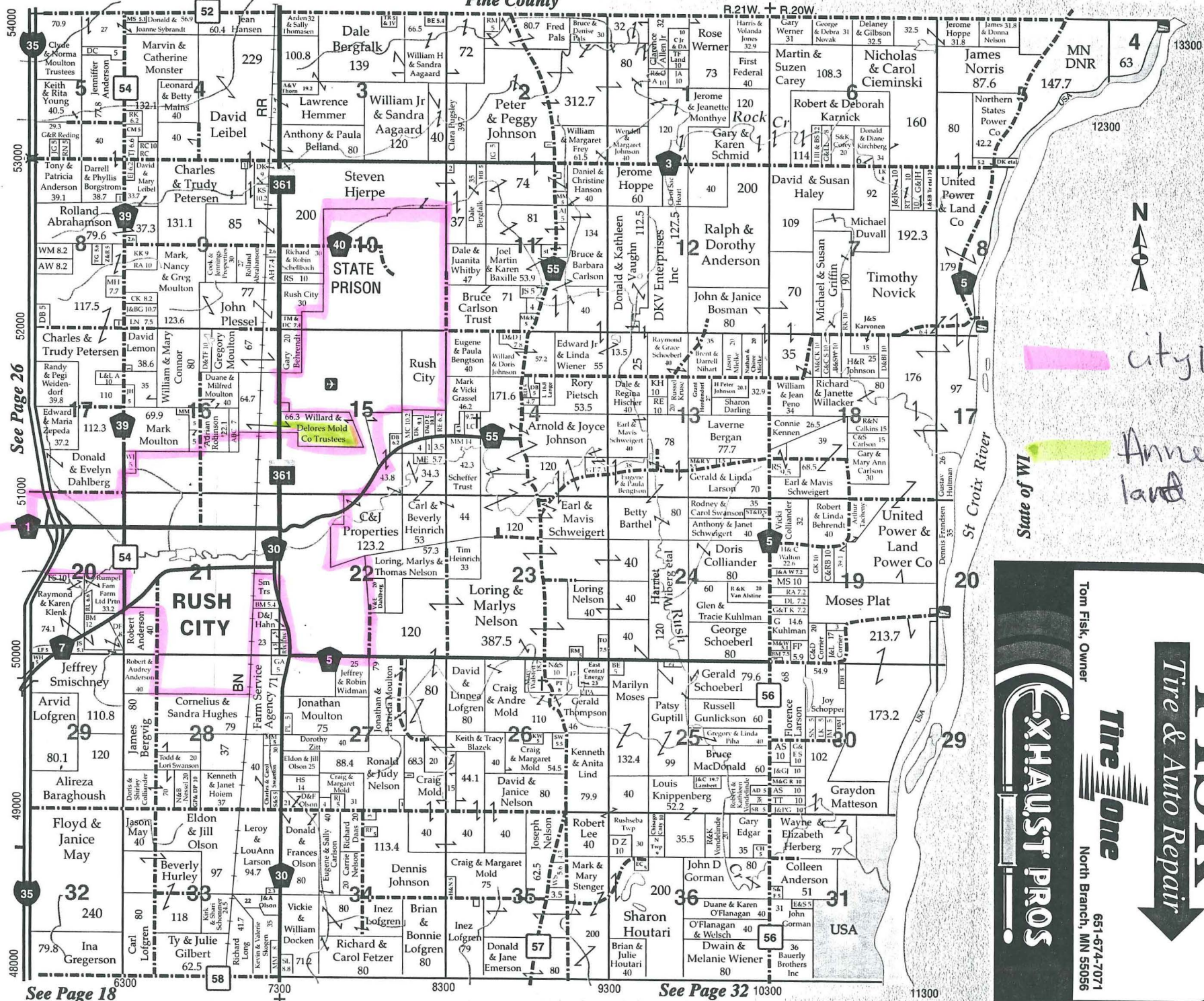

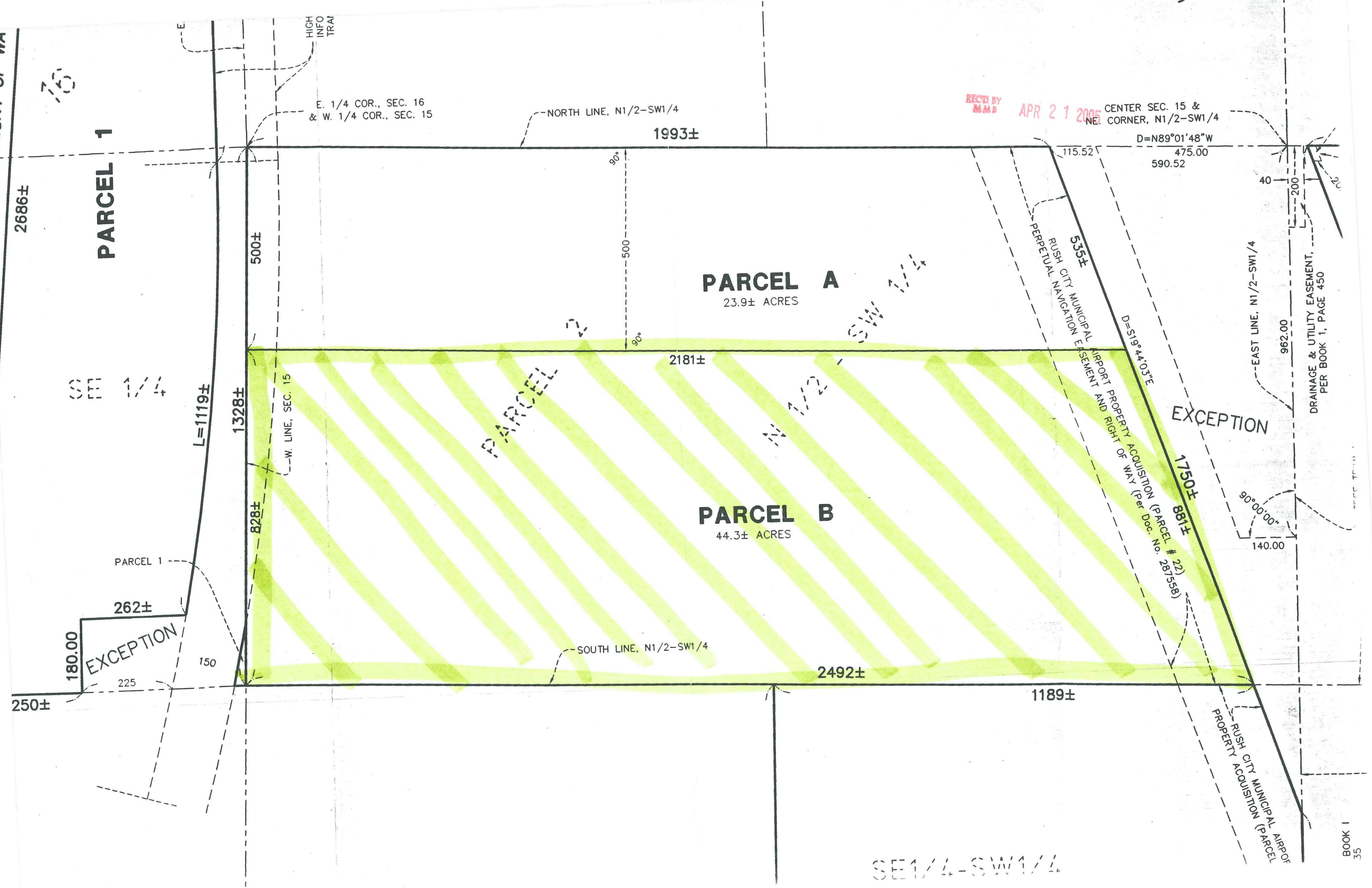
