AN ORDINANCE ANNEXING LAND OWNED BY PATRICIA K. LANG AND LARRY AVENSON AND KAREN AVENSON TO THE CITY OF PARK RAPIDS, HUBBARD COUNTY, MINNESOTA, PURSUANT TO MINNESOTA STATUTES 414.033, SUBD 2(3)

The City Council of the City of Park Rapids, Hubbard County, Minnesota does hereby ordain:

Section 1: Patricia K. Lang and Larry Avenson and Karen Avenson petitioned the City of Park Rapids for annexation of the lands as located in Henrietta Township, Hubbard County, Minnesota, as legally described on the attached Exhibit A.
