## **ORDINANCE NO. 878**

## AN ORDINANCE ANNEXING CERTAIN LANDS INTO THE CITY OF WASECA, MINNESOTA AND ESTABLISHING ZONING THEREOF

WHEREAS, The City of Waseca is the owner of the property, incorporated herein by this reference (the **Property**); and

WHEREAS, the Property is described in Exhibit "A" and depicted in Exhibit "B" attached hereto and incorporated herein by this reference; and

WHEREAS, the Property is located West of the Itron property and north of the Waseca Junior High School, that the Property is less than 60 acres in size, that the Property is not served by public sewer facilities and that public sewer services are not otherwise available, the above described party is the sole owner of the Property, that is not included within any other municipality, and that the electric services provided to the site will not change upon annexation; and

NOW, THEREFORE, THE CITY COUNCIL OF WASECA, MINNESOTA DOES HEREBY DETERMINE, FIND AND ORDAIN:

- <u>Section 1</u>. That the Property is generally located West of the Itron property and North of Waseca Junior High School.
- <u>Section 2</u>. That the Property is 9.61 acres in size, that the Property is not served by public sewer facilities and public sewer facilities are not otherwise available.
- Section 3. That above described party is the sole owner of the Property.
- <u>Section 4</u>. The corporate limits of the City of Waseca are extended to include this property.
- <u>Section 5</u>. The current population of the territory described is 0.
- <u>Section 6</u>. Certified copies of this ordinance shall be filed with The Department of Administration (Municipal Boundary Adjustments), the Minnesota Secretary of State, the Waseca County Auditor, The Waseca County Recorder, and the Clerk of the Woodville Township Board.
- <u>Section 7</u>. This ordinance shall be effective: upon passage and legal publication and filing of the certified copies as described in Sections 5 and 6; and, upon approval of the Ordinance by The Department of Administration, Municipal Boundary Adjustments.
- Section 8. Upon annexation this parcel will be zoned R-2, Urban Residential.

## LEGAL DESCRIPTION – POWELL II
