## City of Zumbrota Ordinance No. 2007-03

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ZUMBROTA TO INCLUDE CERTAIN UNPLATTED LANDS ABUTTING UPON THE CITY LIMITS AND DESIGNATING SUCH LANDS AS I-1, LIMITED INDUSTRIAL DISTRICT; PURSUANT TO MINNESOTA STATUTES SECTION 414.033, SUBDIVISION 2(1), ANNEXATION BY ORDINANCE

WHEREAS, the City of Zumbrota is the owner of the following described real property situate in Goodhue County, Roscoe Township, Minnesota:

See attached Exhibit A (hereinafter referred to as "the Annexed Property").

WHEREAS, the quantity of the Annexed Property is approximately 0.24 acres; is unincorporated property; is owed by the City of Zumbrota, a Minnesota municipal corporation; abuts the Zumbrota City limits; and is deemed to be urban or suburban in character.

WHEREAS, the City deems it appropriate to annex the Annexed Property pursuant to Minnesota Statutes Section 414.033, Subd. 2(1).

WHEREAS, no public hearing is required under Minnesota Statutes Section 414.033, Subd. 2b and no electric utility service notice is required under Section 414.033, Subd. 13.

WHEREAS, the provisions of Minnesota Statutes Section 414.033, Subd. 3 are not applicable in that the perimeter of the area to be annexed is less than 60 percent bordered by the city limits of the City of Zumbrota. Also, the provisions of Section 414.033, Subd. 5 are not applicable.

WHEREAS, the City provided notice to Roscoe Township of its intent to annex the Annexed Property. Roscoe Township has consented to the annexation and has waived any right it may have to object to the proposed annexation.

WHEREAS, none of the Annexed Property is presently served by public wastewater facilities, and public wastewater facilities are not otherwise available.

WHEREAS, the nature of the Annexed Property is consistent with a zoning designation of I-1, Limited Industrial.

WHEREAS, the Annexed Property is not included in any other proceeding currently pending before the Office of Administrative Hearings - Municipal Boundary Adjustments.

WHEREAS, the Annexed Property is not included in any area that has already been designated for orderly annexation pursuant to M.S. 414.0325.

WHEREAS, the City agrees to reimburse Roscoe Township for property taxes imposed on the Annexed Property as follows: lump sum representing eight years of property taxes from and after the time of annexation based upon current use and classification. And,

**WHEREAS**, there are no special assessments assigned by Roscoe Township to the Annexed Property.

**NOW, THEREFORE**, the City of Zumbrota does hereby ordain as follows:

- 1. The City Council hereby determines that the annexation will be in the best interests of the City and of the land affected; that the land described herein abuts upon the City limits, is urban or suburban in character, and that none of the said land is now included within the limits of any city, and does not abut upon the limits of any other city.
- 2. Pursuant to Minnesota Statutes Section 414.033, Subdivision 2(1) (Annexation by Ordinance) the corporate limits of the City of Zumbrota are hereby extended to include the unplatted lands described as follows:

See attached Exhibit A

and the same is hereby annexed to and included within the City of Zumbrota with the effect as if it had originally been a part thereof.

- 3. The land described is to be zoned I-1, Limited Industrial.
- 4. The City shall reimburse Roscoe Township for property taxes on the Annexed Property as follows: lump sum representing eight years of property taxes from and after the time of annexation based upon current use and classification.
- 5. The City Administrator is directed to file certified copies of this Ordinance with the Director of Municipal Boundary Adjustments, the Secretary of State, the Roscoe Township Board, and the Goodhue County Auditor.
- 6. This Ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 5 above and upon the approval of the Director of Municipal Boundary Adjustments.


