The Office of Administrative Hearings is hereby requested to hold public hearings on the question of annexing certain property, known as the Ultimate Service Area of Lansing Township, to the city of Austin Minnesota. The term Ultimate Service Area is the term that both the city of Austin and the Township of Lansing have used to describe the area that needs a sewer system.

The attached petition contains 106 signatures. This is also over 20% of the property owners who live in the Ultimate Service Area.

We are including a complete legal description of the Ultimate Service Area (Exhibit 1); a signed map of the area (Exhibit 2); a signed copy of the City of Austin's resolution to agree to the property owners' request to annex this area by Directors Order in accordance with Minnesota Statutes 2006, section 414.031, subdivision 1a in its amended form (Exhibit 3); a Recap of signers and the legal descriptions of their property, (Exhibit 4); copies of the signed petition sheets (Exhibit 5); as well as a certified check made out to The Office of Administrative Hearings, for \$600. I am also including a packet documenting our quest to obtain the very best sewer system at the minimum cost to the residents in the Ultimate Service Area (Exhibit 6). Please look at the path our sewer task force followed under the direction of Sheila Craig, The Community Sewage Facilitator, from the Southeast Minnesota Wastewater Initiative.

The City of Austin sent a letter to the Clerk of the Lansing Township Board on December 20, 2007, outlining the area to be annexed as well as the legal description of the properties to be annexed with a map showing the areas to be annexed. Lansing Township signed for this certified letter on December 26. We have waited the 30 days to send you the required documents.

In addition to sending the required documents to the Township Clerk, the City Engineer Jon Erichson offered to meet with the township to see if they were willing to reconsider the Orderly Annexation process that the city had previously proposed.

This request has not been arrived at lightly. We have worked on various township committees to resolve the pollution problems that exist in this area. Most recently I served on a task force that was chaired by Sheila Craig, the Community Sewage Treatment Facilitator of the Southeast Minnesota Wastewater Initiative. We met and the entire task force formulated a list of questions for both the city and the township to answer. We then formulated a tabular compilation of their answers. A copy of this tabular presentation is included for your review (Exhibit 7). This tabular

review was included with a ballot which was sent out to all the landowners in the Ultimate Service Area. Included with the ballot was a careful explanation of the consequences of requesting sewer from the city. A brief history of the process that brought us to this point was also included along with a map showing the original Subordinate Service District as well as the Ultimate Service Area. The ballot stated that this was an informational ballot and that it did not bind the city or the township. The ballots were to be returned to Sheila Craig for tabulation. The ballots were to be delivered to Sheila at the meeting by January 25, 2007 or were to be mailed to Sheila Craig with a post mark no later than January 27, 2007. The history, map, and ballot form is included for your review (Exhibit 8).

The ballots were tabulated by Sheila and the results were distributed to the task force members as well as to the city and the township. Copies of these results are included for your review (Exhibit 9). As you can see, 69% of the voters desired to have their sewer service provided by the city of Austin and 5% desired to have their service provided by the Township of Lansing.

We are also including other pertinent documents that establish the integrity of our task force.

Some of the residents of our area have recently been cited by the MPCA for having straight pipe discharges to the river. Please act as soon as possible to move this process forward to minimize the hardship on our residents and to eliminate the unhealthy practices that are now taking place.



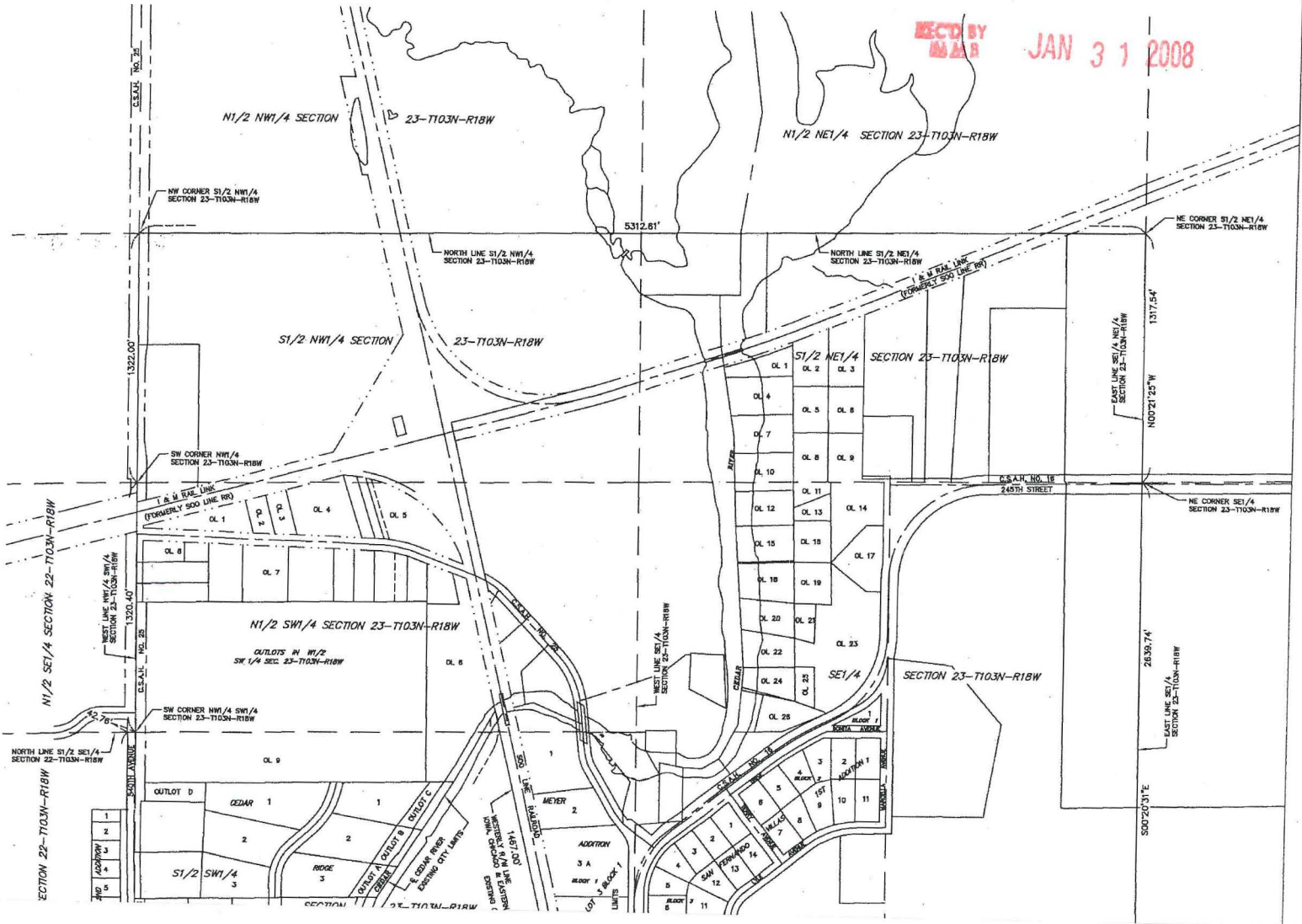
