ORDINANCE NO. 593, SECOND SERIES

AN ORDINANCE OF THE CITY OF MARSHALL ANNEXING LAND LOCATED IN THE TOWN OF FAIRVIEW, LYON COUNTY, MINNESOTA TO THE CITY OF MARSHALL, LYON COUNTY, MINNESOTA, PURSUANT TO MINNESOTA STATUTES, SECTION 414.033, SUBDIVISION 2(3), PERMITTING ANNEXATION BY ORDINANCE

THE CITY OF MARSHALL DOES HEREBY ORDAIN:

Section 1. That the unincorporated land legally described in Exhibit A, which is attached hereto and incorporated herein by reference, located in the Town of Fairview, Lyon County, Minnesota, is land that is contiguous to and abuts the municipal corporate limits of the City of Marshall, Lyon County, Minnesota; is land that is 120 acres or less in size; is land that is not presently served by public sewer facilities, and for which public sewer facilities are not otherwise available than through the City of Marshall; and is land that is existing or proposed for immediate urban or suburban development.

Section 2. That the owner of the property legally described in <u>Exhibit A</u> has requested annexation for purposes of immediately developing the land for additional urban or suburban commercial uses needing municipal services, and has submitted a petition to the City Council of the City of Marshall for annexation of said land.

Section 3. That the City of Marshall held a public hearing pursuant to Minnesota Statutes, Section 414.033, Subdivision 2b, on May 5, 2008, following thirty (30) days' written notice by certified mail to the Town of Fairview and to all landowners within and contiguous to the area, legally described in Exhibit A, to be annexed.

Section 4. That the corporate limits of the City of Marshall are hereby extended to include the land legally described in <u>Exhibit A</u>, and shown on the map attached hereto and incorporated herein by reference as <u>Exhibit B</u>, containing 5.617 acres, and the same is hereby annexed to be included within the City of Marshall, Lyon County, Minnesota.

Section 5. That the population of the area legally described in Exhibit A, and hereby annexed, is $\underline{0}$.

Section 6. The City of Marshall and the Town of Fairview have agreed, pursuant to Minnesota Statutes, Section 414.036, that with respect to property taxes payable on the area legally described in Exhibit A, hereby annexed, the City of Marshall shall make a cash payment to the Town of Fairview for the period and in accordance with the following section:

- a. In the first year following the year the City of Marshall could first levy on the annexed area, an amount equal to \$10.48; and
- b. In the second and final year, an amount equal to \$10.48.

Section 7. That pursuant to Minnesota Statutes, Section 414.036 with respect to any special assessments assigned by the Township to the annexed property and any portion of debt incurred by the Township prior to the annexation and attributable to the property to be annexed, but for which no special assessments are outstanding, for the area legally described in Exhibit A,

there are no special assessments or debt incurred by the Township on the subject area for which reimbursement is required.

Section 8. That the Finance Director/City Clerk of the City of Marshall is hereby authorized and directed to file a copy of this Ordinance with the Minnesota Office of Administrative Hearings Municipal Boundary Adjustments Office, the Minnesota Secretary of State, the Lyon County Auditor, and the Fairview Township Clerk.

Section 9. That this Ordinance shall be in full force and effect and final upon the date this Ordinance is approved by the Minnesota Office of Administrative Hearings.


