NOTICE OF INTENT TO ANNEX CERTAIN LANDS FROM CANNON CITY TOWNSHIP

PLEASE TAKE NOTICE, the City of Faribault intends to annex property containing approximately 34.28 acres from Cannon City Township pursuant to Minnesota Statutes, Section 414.033, subdivision 3. The property to be annexed is legally described in Exhibit A and shown on Exhibit B. The perimeter of the property is 60 percent or more bordered by the City and contains 40 acres or less.

The Town Board has up to 90 days from the date of service of this notice to file objections concerning the intended annexation with the Chief Administrative Law Judge as provided in law. If objections are filed, the Office of Administrative Hearings will conduct a hearing pursuant to Minnesota Statutes, section 414.031, subd. 3 & 4 and issue an order concerning the annexation. If no objections are filed, the City Council intends to adopt an ordinance annexing the Property at their November 25, 2008 regular meeting, in the City Hall Council Chambers, 208 1st Avenue NW at 7:00 p.m.





Cannon City Annexation by Ordinance Under 40 Acres-Over 60% Surrounded




