I.

The undersigned petitioner is the owner and does hereby request and desire that certain lands be annexed to the City of Silver Lake, McLeod County, Minnesota, and to be included within the corporate limits of the City of Silver Lake, said lands being in the County of McLeod, State of Minnesota, described as follows, to-wit:

**That part of the Southwest Quarter of the Southwest Quarter of Section 27 in Township 117 North of Range 28 West described as follows, to-wit:
Beginning at a point on the South line of said Section 27, 18 rods East of the Southwest corner of said Section 27, thence East 5 rods; thence North 16 rods; thence West 5 rods; thence South to the point of beginning.**

II.

The said lands described in the preceding paragraph abut the present corporate limits of the City of Silver Lake. A map of said land subject to this petition is attached hereto and consists of less than one acre. The lands are unplatted and are not now included in any other municipality.

III.

No Petition for Annexation of any part of said lands is presently before the Commission or the City of Silver Lake.

IV.

The petitioner constitutes the only landowner having any interest in said lands.

V.

The undersigned petitioner believes that said lands are now or about to become urban or suburban in character and the annexation of said lands to the City of Silver Lake would be in the best interest of the City of Silver Lake, Minnesota.


VI.



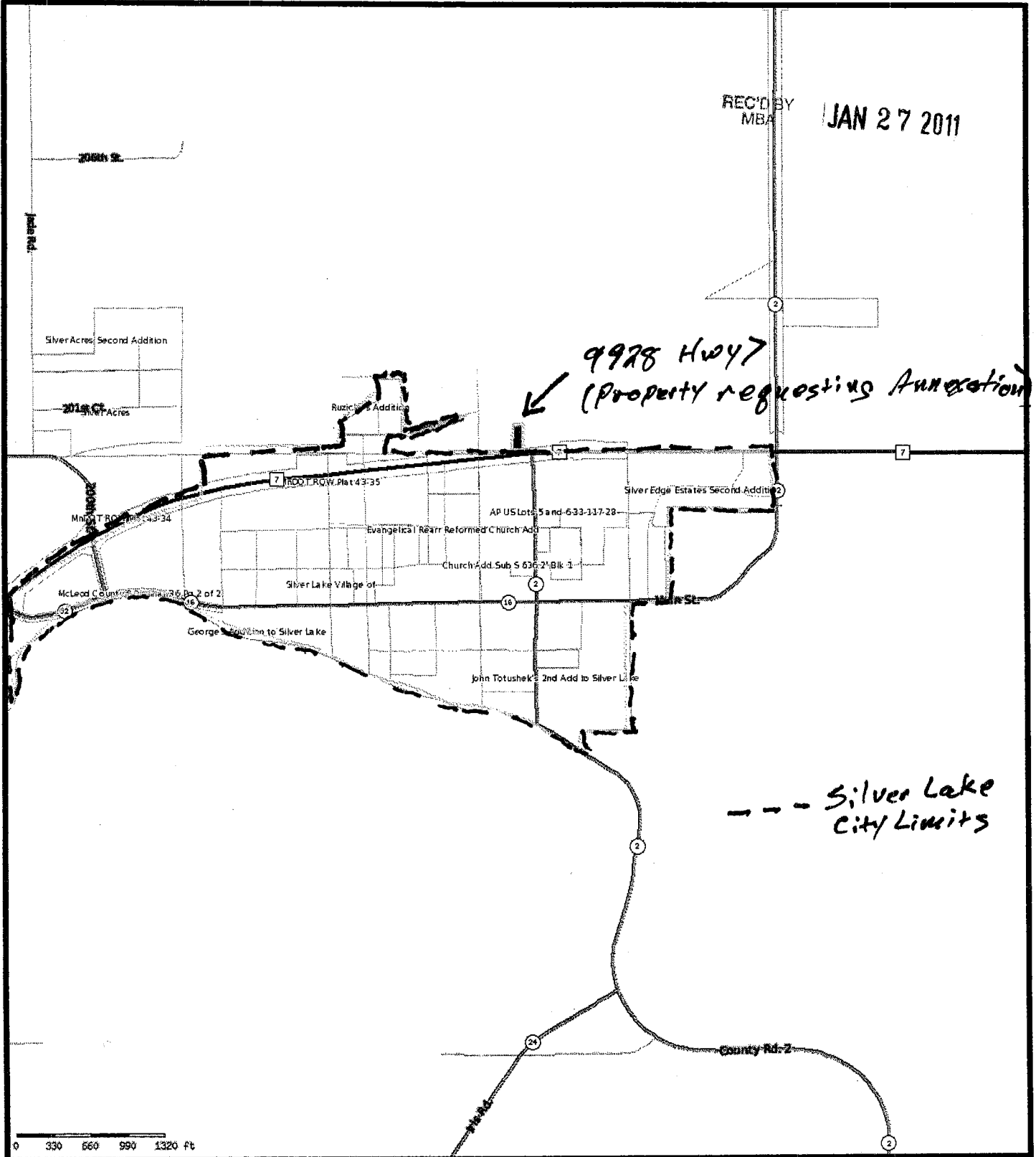

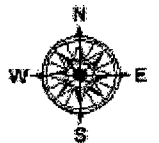

McLeod County, MN - Map



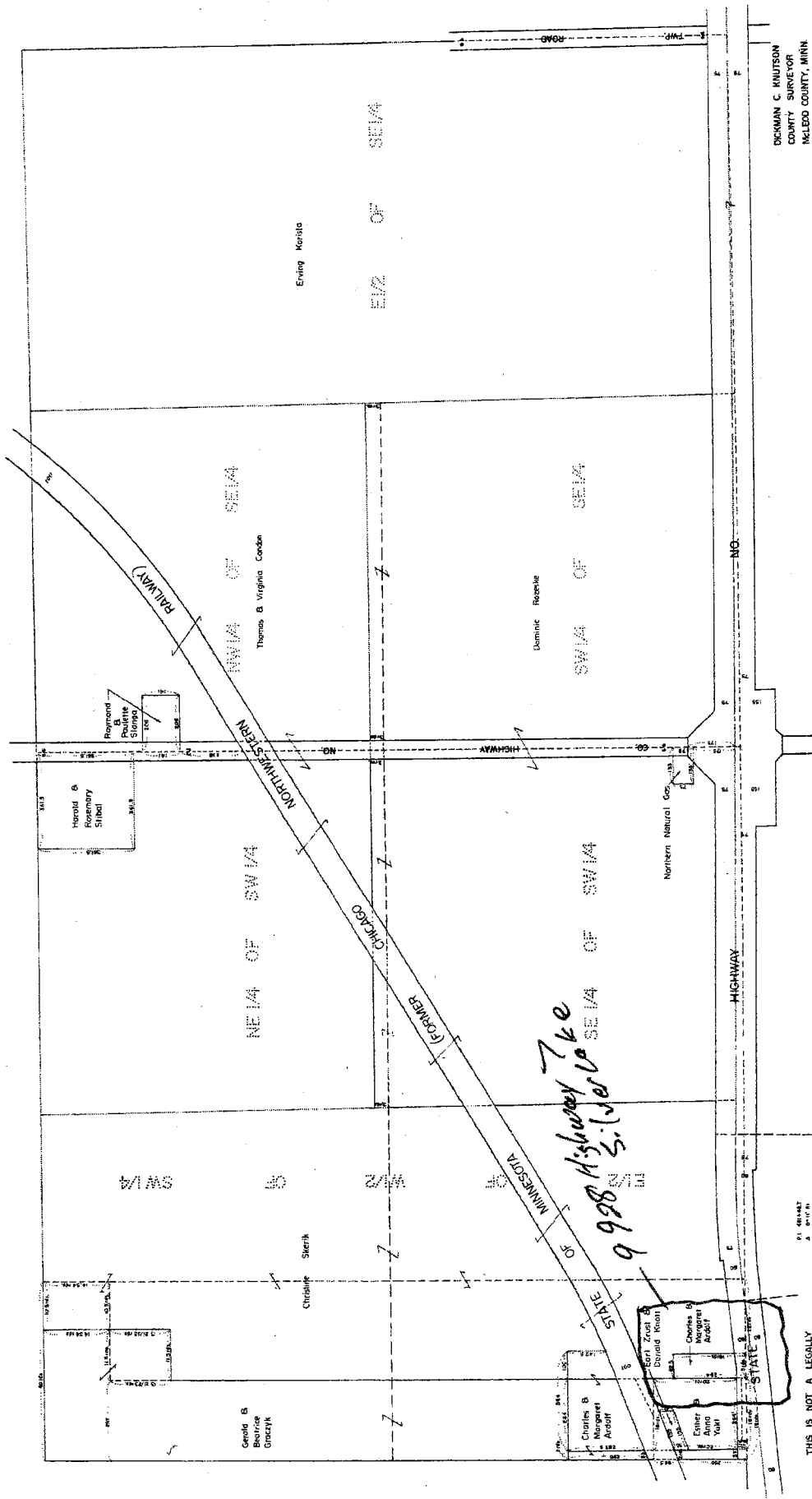
