ORDINANCE NO. 84

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF VERGAS TO INCLUDE CERTAIN UNINCORPORATED PROPERTY ABUTTING UPON THE LIMITS OF THE CITY

WHEREAS, R.J. Roswick and Julie Roswick are the owners of the following described property:

See Exhibit A.

WHEREAS, the property is not presently within the corporate limits of any incorporated city, village or borough; and

WHEREAS, the territory to be annexed consists of unplatted land, not exceeding 200 acres, all of which lie within the County of Otter Tail, State of Minnesota;

WHEREAS, the property described within Exhibit A abuts upon the Vergas City limits at the boundary thereof and none of it is presently included within the corporate limits of any incorporated city; and

WHEREAS, all of this territory is or is about to become urban or suburban in character; and

WHEREAS, all of the owners of the property contained within the land described on Exhibit A have petitioned to have this territory annexed to the City and to extend the City boundaries to include the same; and

WHEREAS, copies of the Petition were filed with and served upon the Township of Candor and Otter Tail County on or about May 1, 2012, by certified mail;

WHEREAS, copies of the Petition and supporting documents were filed with the Minnesota Boundary Adjustment Board on August 24, 2012;

WHEREAS, no written objections were submitted within the time period allowed by Minnesota Statute 414.033, Subdivision 5; and

NOW, THEREFORE, THE CITY COUNCIL OF VERGAS, MINNESOTA DOES HEREBY ORDAIN:

Section 1. <u>Territory Annexed.</u> The corporate limits of the City of Vergas, Minnesota are hereby extended to include the unplatted property described on the attached Exhibit A, which is attached hereto and incorporated by reference herein.

Section 2. <u>Filing.</u> The City Clerk is directed to file certified copies of this ordinance with the Township of Candor, the Minnesota Secretary of State, the

Otter Tail County Auditor and the Minnesota Boundary Adjustment Board pursuant to Minnesota Statutes 414.033, Subdivision 7.

Section 3. <u>Effective Date of Annexation.</u> This ordinance is effective and final on the date of publication and upon approval by the Director, Minnesota Boundary Adjustment Board.
