**A Resolution Waiving the Township's Right to Object to a Petition of Annexation
By Ordinance Regarding Property Located in Shingobee Township**

WHEREAS, pursuant to Minn. Stat. §414.033, Subd. 5, Daniel and Michele Piprude have filed a Petition for Annexation by Ordinance relating to 4.57 acres of property identified as Tract 5 and Tract 5A located in part of Government Lot 2, Section 35, Township 142 North, Range 31 West, Cass County, Minnesota which is situated in Shingobee Township; and

WHEREAS, through their Petition for Annexation by Ordinance, Daniel and Michele Piprude are requesting said property to be annexed to and included within the City of Walker, Minnesota; and

WHEREAS, said Petition for Annexation by Ordinance was served on Shingobee Township on or about November 7, 2013 and pursuant to Minn. Stat. §414.033, Subd. 5, the Township may submit written objections to the annexation within 90 days from the date of service; and

WHEREAS, pursuant to Minn. Stat. §414.033, Subd. 6, the Township may waive its right to object and to waive the 90-day period before an annexation ordinance may be adopted.

NOW, THEREFORE, BE IT RESOLVED, that the Shingobee Township Board of Supervisors has no objection to the said Petition for Annexation by Ordinance and pursuant to Minn. Stat. §414.033, Subd. 6 waives its right to file written objections to the annexation and further waives the 90-day period before an annexation order may be adopted.

WHEREAS, the motion for the adoption of the foregoing Resolution was made by Supervisor Bresley, seconded by Supervisor Orton and it was declared adopted upon the following vote: Ayes: 5 (Bresley, Beard, Orton, Laursen, Geiser) and Nays: 0
