ORDINANCE NO. 374

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF DETROIT LAKES, MINNESOTA TO INCLUDE CERTAIN UNINCORPORATED TERRITORY OWNED BY AND ABUTTING UPON THE LIMITS OF THE CITY (UPSTREAM SUCKER CREEK)

WHEREAS, Certain territory described below is not presently included within the corporate limits of any incorporated city or borough; and

WHEREAS, The territory abuts upon the corporate limits of the City at the easterly boundary thereof and is deemed to be urban or suburban in character; and

WHEREAS, The territory is owned in fee by the City and can be annexed by ordinance under SS 414.033, Subd. 2 (1),

THE City Council of the City of Detroit Lakes, Minnesota, does hereby ordain:

Section 1. <u>Territory Annexed.</u> The corporate limits of the City of Detroit Lakes are hereby extended to include the un-platted territory described as follow:

Government Lot Two (2), Less the South 990 feet AND all Government Lot One (1), all in Section Eighteen (18) Township 138 North of Range 40 West of the 5th PM in Becker County, Minnesota, and

The South 990 feet of government Lot Two (2), Section Eighteen (18), Township 138 North of Range 40 West of the 5th PM in Becker County, Minnesota.

Less the following described tract: The South 800 feet of Government Lot Two (2), Section Eighteen (18) Township 138 North of Range 40 West of the 5th P.M. in Becker County, Minnesota.

The above described tract contains 52.7 acres.

Section 2. Filing. The City Clerk is directed to file certified copies of this Ordinance with the Secretary of State, the County Auditor of the County in which the property is located, the Township Clerks of the affected Townships, and the Minnesota Municipal Board.

Section 3. <u>Population.</u> The population of the annexed territory is zero.

Section 4. <u>Effective Date of Annexation.</u> This Ordinance takes effect upon passage and publication, the filing of certified copies as directed in Section 2, and approval by the Office of Administrative Hearings.




