IN THE MATTER OF THE PETITION FOR ANNEXATION OF UNINCORPORATED ADJOINING PROPERTY LOCATED ALONG MEADOW LANE AND DONNA DRIVE (HANSEN/BARTHOLOMEW), ALEXANDRIA, MINNESOTA

TO THE CITY OF ALEXANDRIA AND THE STATE OF MINNESOTA

WE, THE UNDERSIGNED, the owner(s) of the property described below, hereby petition the Alexandria City Council to annex this territory to the City of Alexandria, Minnesota and for that purpose respectfully state:

- 1. The petitioners are the owners of the subject property.
- 2. Pursuant to Minn. Stat. Section 414.033, Subdivision 5, the petition is a majority (75%) of the property owners within the affected area. (Four (4) property owners and three petitioners.)
- 3. The property currently abuts upon the northwesterly boundaries of the Alexandria City Limits along the southwesterly boundary of the subject property and is not presently a part of any incorporated city.

 Douglas County, containing approximately 1.46 acres in three (3) parcels
