ORDINANCE NO.

AN ORDINANCE ANNEXING UNINCORPORATED LANDS IN CARLTON COUNTY, MINNESOTA, INTO THE CITY OF CROMWELL, CARLTON COUNTY, MINNESOTA, PURSUANT TO MINNESOTA STATUTES 414.033, SUBD. 2(3), PERMITTING ANNEXATION BY ORDINANCE

The City Council of the City of Cromwell, Carlton County, Minnesota, hereby ordains:

SECTION I. That all the owners of lands to be annexed, hereinafter described, executed

a Petition for annexation (a copy of which is attached), and that said unincorporated lands,

approximating one and one-tenth (1.1) acres in size, are described in that Petition and are legally

described in Section IV herein and are currently located within Carlton County, Minnesota.

SECTION II. That said lands are urban or suburban in character or about to become so,

said lands being unoccupied residential lands which will not immediately affect the population of

the City of Cromwell.

SECTION III. That said lands abut the existing corporate limits of the City of

Cromwell, are platted, and consist of approximately 1.1 acres.

SECTION IV. Said lands are located in Carlton County, Minnesota, and are legally

described as follows:

Lot 12 Block 1, Tucci, according to the plat thereof on file and of record in the office of the Carlton County Recorder; and, A tract of land in Government Lot 1 of Section 33, Township 49 North, Range 20 West of the Fourth Principal Meridian, more particularly described as follows, to-wit: Commencing At the East quarter corner of said Section 33; thence bearing North 89° 13' 11" West on the quarter section line a distance of 453.24 feet to the point of beginning of the tract to be herein described; thence bearing North 36° 39' 56" West a distance of 201.93 feet to a point; thence bearing South 86° 49' 13" West a distance of 215.6 feet, more or less, to the shore of Island Lake; thence in a general South and Southeasterly direction on said shoreline a distance of 150 feet, more or less, to the quarter section line; thence bearing South 89° 13'11" East on said quarter section line a distance of 347.27 feet, more or less, to the point of beginning. **SECTION V.** That at least thirty (30) days before the Petition for Annexation in the within matter was considered at a public hearing, written notices were sent by certified mail to the County of Carlton and all landowners within and contiguous to the 1.1 acre parcel being annexed.

SECTION VI. That the Petition was signed, dated, and filed with the City on <u>September</u> <u>17, 2010</u>, the required notices were duly mailed, and the public hearing on the petition was held; no objections to the annexation being noted or received. The City previously approved the ordinance on <u>November 17, 2010</u>, but the City Clerk did not file the documents in a timely fashion. This updated approval by the City is passed to cure that oversight.

SECTION VII. That the purpose of the annexation is to extend public sewer services to the parcel being annexed where such services are presently not available.

SECTION VIII. That consistent with the foregoing it is the intent of the City Council that the aforesaid lands are hereby duly annexed to the City of Cromwell.

SECTION IX. The City Clerk is hereby directed to forthwith file copies of this ordinance with the Office of Administrative Hearings, the Secretary of State, by filing copies with the Carlton County Recorder and the Carlton County Auditor.

SECTION X. This Ordinance shall become effective and said land duly annexed to the City of Cromwell upon the due passage and enactment hereof, approval by the Office of Administrative Hearings and publication of this Ordinance according to law.
