In the Matter of the Annexation of Certain Real Property to the City of Lindstrom from Chisago Lake Township (MBAU Docket A-7969)

ORDER APPROVING ANNEXATION ORDINANCE

On December 17, 2015, the city of Lindstrom (City) adopted Ordinance Number 20151217-01 (Ordinance) annexing certain real property (Property) legally described as follows:

Those parts of the Northwest Quarter of the Southeast Quarter (NW¼ of SE¼), and Government Lot Two (2), both in Section Four (4), Township Thirty-three (33) North, Range Twenty (20) West, Chisago County, Minnesota, described as follows:

Commencing at the east quarter corner of said Section 4; thence South 89°46'27" West, assumed bearing, along the east-west quarter line of said Section 4 a distance of 820.34 feet; thence South 0°13'33" East 332.34 feet; thence South 10°18' East 254.41 feet to the point of beginning; thence South 13°54' West 408.55 feet; thence South 23°12' West 299.83 feet; thence South 89°47'06" West, parallel with the south line of said Government Lot 2 and the Northwest Quarter of the Southeast Quarter, 373 feet, more or less, to the east right-of-way line of the existing County State Aid Highway No. 25; thence northerly along said east right-of-way line 670 feet, more or less, to the intersection with a line that bears South 89°46'27" West from the point of beginning; thence North 89°46'27" East 600 feet, more or less, to the point of beginning.

Based upon a review of the Ordinance, the Chief Administrative Law Judge makes the following:

ORDER

- 1. Pursuant to Minn. Stat. § 414.033 (2014), the Ordinance is deemed adequate in all legal respects and properly supports this Order.
- 2. Pursuant to the terms of the Ordinance and this Order, the Property is **ANNEXED** to the City.

3. Pursuant to Minn. Stat. § 414.036 (2014), the City will reimburse Chisago Lake Township (Township) \$198.08 on July 1, 2016 and July 1, 2017, as stated in the Ordinance.
