Council Member Braun introduced the following resolution and moved for its adoption.

RESOLUTION NO. 2015-23

A RESOLUTION FOR THE ANNEXATION OF CERTAIN LANDS INTO THE CITY OF WELLS PURSUANT TO MINNESOTA STATUTES SECTION 414.031

WHEREAS, the City of Wells owns 320.80 acres of land in Clark Township, Faribault County, Minnesota currently used as the site for the wastewater treatment ponds that serve the City of Wells and the Cities of Easton and Minnesota Lake in Minnesota as well as the site for a City owned storage facility and the local gun club shooting range; and

WHEREAS, Faribault County, Minnesota currently has jurisdiction over said lands for zoning purposes and is now requiring a conditional use permit for all uses on the land owned by the City of Wells; and

WHEREAS, the City of Wells as the owner of said certain tracts now desires to annex into City boundaries its tracts to gain regulatory zoning authority for said tracts and certain tracts adjoining said tracts and/or the current City boundaries; and

WHEREAS, the tracts to be annexed all border State Highway 109 as said highway runs west and from current City boundaries and is appropriate for future commercial or residential growth of the City of Wells.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WELLS:

1. That the tract of land legally described in the attached Exhibit "A" and shown on the map attached hereto as Exhibit "B" be hereby annexed into the City municipal boundaries of the City of Wells upon approval of the annexation thereof by the State of Minnesota pursuant to the provisions of Minnesota Statutes Section 414.031, Subd. 1; and

2. That notice of this Resolution shall be given to Clark Township, Faribault County, Faribault County Planning and Zoning and all affected property owners by US Mail in addition to any Notice of Hearing required by Minnesota Statutes, Section 414.09.

The motion for the adoption of the foregoing resolution was duly seconded by Council Member Harig and upon vote being taken thereon, the following voted in favor:



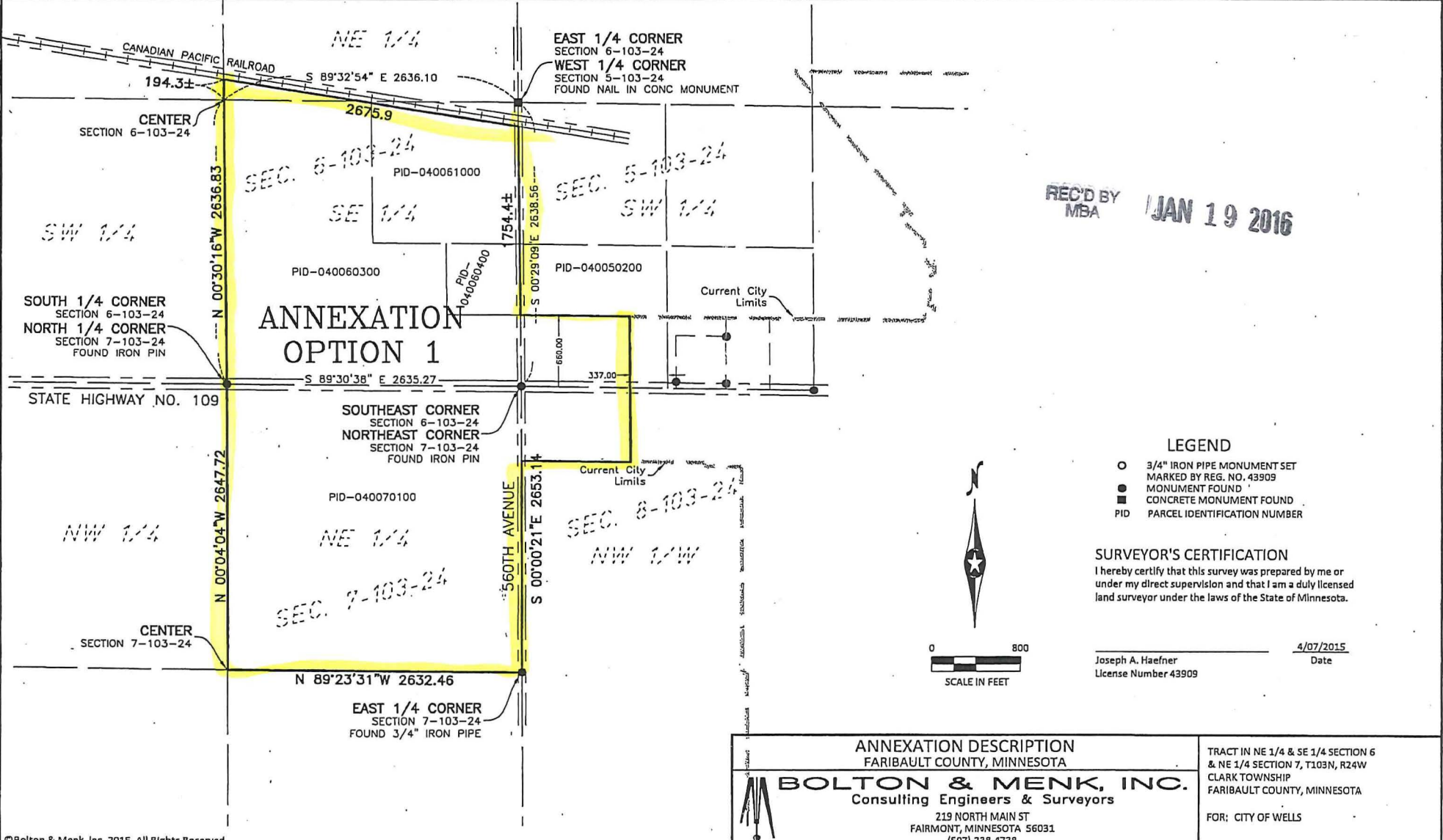
