#### Ordinance No. 2016-1

# An Ordinance of the City of St. Anthony, Minnesota Annexing Land Located in Krain Township, Stearns County, Minnesota Pursuant to Minnesota Statutes § 414.033 Subdivision 2(3), Permitting Annexation by Ordinance

Whereas, a petition signed by all the property owners, requesting that property legally described in the attached Schedule of Real Property (the "Property") be annexed to the City of St. Anthony, Minnesota, was duly presented to the Council of the City of St. Anthony on 12/15, and

Whereas, the Property is unincorporated and abuts the City of St. Anthony on its southerly and easterly boundaries; is less than 120 acres; is not presently served by public sewer facilities or public sewer facilities are not otherwise available; and

Whereas, the Property is not located within a flood plain or shoreland area; and

Whereas, the Property is currently rural and annexation is requested to facilitate the residential development of the property; and

Whereas, the City of St. Anthony held a public hearing pursuant to Minnesota Statutes § 414.033 Subd. 2b, on January 26, 2016, following 30 days written notice by certified mail to the Town of Krain and to all landowners within and contiguous to the territory to be annexed; and

Whereas, provisions of Minnesota Statutes § 414.033 Subd. 13 are not applicable in that there will be no change in the electric utility service provider resulting from the annexation of the territory to the municipality.

Now, Therefore, the City Council of the City of St. Anthony hereby ordains as follows:

- 1. The City Council hereby determines that the Property as hereinafter described abuts the city limits and is or is about to become urban in nature in that residential use is being proposed for the Property.
- 2. None of the Property is now included within the limits of any city, or in any area that has already been designated for orderly annexation pursuant to Minnesota Statutes § 414.0325.
- 3. The corporate limits of the City of St. Anthony, Minnesota, are hereby extended to include the Property, said land abutting the City of St. Anthony and being 120 acres or less in area, and is not presently served by public sewer facilities or public sewer facilities are not otherwise available, and the City having received a petition for annexation from all the property owners of the land.
- 4. The Property consists of a total of 0.12 acres, more or less.

- 5. That the population of the area legally described in the Property and hereby annexed is zero.
- 6. The City of St. Anthony, pursuant to Minnesota Statutes § 414.036, with respect to the property taxes payable on the Property, hereby annexed, shall make a cash payment to the Town of Krain in accordance with the following schedule:

Reimbursement of the property taxes to the Town shall be based on the property taxes collected by the Town in the last year it collected taxes on the annexed area, in a total amount equivalent to that payable under the former law, but adjusted to be paid in substantially equal payments over two years in accordance with the 2006 amendments to Minnesota Statutes §414.036.

- 7. That pursuant to Minnesota Statutes § 414.036, with respect to any special assessments assigned by the Town to the annexed property and any portion of debt incurred by the Town prior to the annexation and attributable to the property to be annexed, but for which no special assessments are outstanding, there are no special assessments or debt incurred by the Town on the Property for which reimbursement is required.
- 8. That the City Clerk of the City of St. Anthony is hereby authorized and directed to file a copy of this Ordinance with the Municipal Boundary Adjustment Unit of the Office of Administrative Hearings, the Minnesota Secretary of State, the Stearns County Auditor, and the Krain Township Clerk.
- 9. That this Ordinance shall be in full force and effect and final upon the date this Ordinance is approved by the Office of Administrative Hearings.


