AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF RAYMOND TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND OWNED BY THE CITY OF RAYMOND

WHEREAS, the land described herein abuts upon the city limits; and

WHEREAS, all said land is owned by the city of Raymond; and

WHEREAS, lands owned by a municipality may be annexed pursuant to M.S.A. §414.033; and

NOW, THEREFORE, the council of the city of Raymond, Minnesota, ordains:

Section 1. The city council hereby determines (1) that the land described herein abuts upon the city limits; (2) that none of the land is now included within the limits of any other city; and (3) the land is owned by the city of Raymond.

Section 2. The population of the territory is less than 100.

Section 3. Territory Annexed. The corporate limits of the city are hereby extended to include the land described as follows and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof:

Section 4. Filing. The city clerk is hereby directed to file certified copies of this ordinance with the Chief Administrative Law Judge, the Secretary of State, the Township Clerk, and the County Auditors of Kandiyohi County and Chippewa County.

Section 5. Effective Date. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 4, and approval of the ordinance by the State of Minnesota Municipal Board of Adjustments.








Proposed Annexation
