ORDINANCE NO.2016-103

AN ORDINANCE OF THE CITY OF RICHMOND, MINNESOTA ANNEXING LAND LOCATED IN MUNSON TOWNSHIP, STEARNS COUNTY, MINNESOTA PURSUANT TO MINNESOTA STATUTES § 414.033 SUBDIVISION 2, CLAUSE (1), PERMITTING ANNEXATION BY ORDINANCE OF LAND OWNED BY A MUNICIPALITY

WHEREAS, the property legally described in the attached Exhibit A (the "Property") is owned by the City of Richmond (the "City");

WHEREAS, the Property is unincorporated and abuts the City on its western boundary;

WHEREAS, the Property is deemed to be urban or suburban in character; and

WHEREAS, the City plans to annex the Property pursuant to Minn. Stat. § 414.033, Subd. 2, Clause (1).

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RICHMOND HEREBY ORDAINS AS FOLLOWS:

- 1. The City Council of the City hereby determines that the Property abuts the City limits and the Property is urban or suburban in nature or is about to become so.
- 2. The Property is owned by the City and is not in any area that has already been designated for orderly annexation pursuant to Minnesota Statute § 414.0325.
- 3. The corporate limits of the City are hereby extended to include Property pursuant to Minn. Stat. § 414.033, Subd. 2, Clause (1).
- 4. That the population of the Property hereby annexed is: zero (0)
- 5. With respect to reimbursement of real estate taxes payable on Property, identified as parcel #23.13536.0000 by Stearns County, is a tax exempt property for the purposes of real estate taxes.
- 6. That the City Clerk of the City is hereby authorized and directed to file a copy of this Ordinance with the Municipal Boundary Adjustment Unit of the Office of Administrative Hearings, the Minnesota Secretary of State, the Stearns County Auditor, and the Munson Township Clerk.
- 7. That this Ordinance shall be in full force and effect and final upon the date this Ordinance is approved by the Office of Administrative Hearings.
