

ORDINANCE NO. 702 (Annexation)

CITY OF WACONIA

CARVER COUNTY, MINNESOTA

MARCH 13, 2017

AN ORDINANCE ANNEXING CERTAIN LAND INTO THE CORPORATE LIMITS OF THE CITY OF WACONIA, CARVER COUNTY, MINNESOTA, PURSUANT TO MINNESOTA STATUTES SECTION 414.033.

THE CITY COUNCIL OF THE CITY OF WACONIA MAKES THE FOLLOWING FINDINGS:

- A. The City of Waconia is the sole owner in fee simple of certain land as legally described on Exhibit A and as depicted as the "Area To Be Annexed" on Exhibit B attached to this Ordinance and made a part hereof (the "Land").
- B. The Land is presently located within the Township of Waconia, Carver County.
- C. The City of Waconia desires to annex said Land pursuant to Minnesota Statutes Section 414.033, Subd. 2(1), permitting annexation by ordinance.
- D. The City of Waconia is not required to hold a public hearing or give written notice to the Township of Waconia or landowners within and contiguous to the area to be annexed pursuant to Minnesota Statutes Section 414.033, Subd. 2(b) because the Land is owned by the City of Waconia.
- E. The Land: i) Abuts the present corporate limits of the City of Waconia; ii) Is not included with any other municipality; iii) Is vacant and will remain vacant for the near future; iv) Is urban or suburban in character; v) Has not already been designated for orderly annexation pursuant to Minnesota Statutes Section 414.0325; and vi) Is an appropriate area to be subject to municipal government.
- F. Annexation of the Land will be in the best interest of the City of Waconia.
- G. The Land is vacant and will not affect the population of the City at this time.
- H. That pursuant to Minnesota Statutes Section 414.036 there are no special assessments or debt assessed by the Township of Waconia to the land to be annexed.

NOW, THEREFORE, the City Council of the City of Waconia, Carver County, Minnesota, ordains:

- 1. The above stated findings are incorporated in and made a part of this Ordinance.
- The corporate limits of the City of Waconia are hereby declared extended to encompass and include all that certain land as described on Exhibit A and as depicted as the "Area To Be Annexed" on Exhibit B attached hereto.
- 3. No cash reimbursement is payable to Waconia Township pursuant to Minnesota Statutes Section 414.036 for the Land annexed because the Land is tax exempt.
- 4. Pursuant to Minnesota Statutes Section 414.033, Subd. 7, the City Clerk is hereby authorized and directed to file copies of this Ordinance with the State of Minnesota Chief Administrative Law Judge, Waconia Township, the Carver County Auditor (Taxpayer Services Department), and the Minnesota Secretary of State.
- 5. This Ordinance is final and in full force and effect on the date this Ordinance is approved by the Chief Administrative Law Judge.

EXHIBIT A Land To Be Annexed

Commencing at the southeast corner of Section 24, Township 116, Range 25; thence North along the east line of said Section 24, a distance of 733.5 feet to the point of beginning for a parcel of land to be described herein; thence deflecting left 35 degrees 34 minutes and running northwesterly a distance of 718.07 feet to a point on the north line of the Southeast Quarter of the Southeast Quarter of said Section 24; thence deflecting right 125 degrees 08 minutes and running east along the north line of said Southeast Quarter of the Southeast Quarter, a distance of 80.7 feet to a point; thence deflecting right 54 degrees 52 minutes and running southeasterly a distance of 579.3 feet to a point on the east line of said Section 24; thence deflecting right 35 degrees 34 minutes and running south along the east line of said Section 24, a distance of 113.47 feet to the place of beginning. Subject to all easements of record.



Commencing at the southeast corner of Section 24, Township 116, Range 25; thence north along the east line of said Section 24, a distance of 1254.4 feet to the point of beginning for a parcel of land to be described herein; thence deflecting left 120 degrees 03 minutes and running southwesterly a distance of 238.47 feet to a point; thence deflecting right 84 degrees 29 minutes and running northwesterly a distance of 33.12 feet to a point; thence deflecting right 95 degrees 31 minutes and running northeasterly a distance of 260.74 feet to a point on the east line of said Section 24; thence deflecting right 120 degrees 03 minutes along the east line of said Section 24, a distance of 38.12 feet to the place of beginning. Subject to all easements of record.

Except that part of above described parcels lying within Parcel 8, CARVER COUNTY RIGHT OF WAY PLAT NO. 10, according to the plat of record, Carver County, Minnesota.


Old County Hwy No. 10 Corridor Annexation
