In the Matter of the Annexation of Certain Real Property to the City of Le Sueur from Ottawa Township (MBAU Docket A-8156)

ORDER APPROVING ANNEXATION ORDINANCE

On May 29, 2018, the City of Le Sueur (City) adopted Ordinance Number 570 (Ordinance) annexing certain real property (Property) from Ottawa Township (Township) legally described as follows:

which lies northeasterly of a line describes as follows:

Commencing at the southeast corner of the Southwest Quarter of said Section 2; thence North 44 degrees 08 minutes 02 seconds West, assuming the east line of the Southwest Quarter of said Section 2 bears North 00 degrees 19 minutes 54 seconds East, a distance of 673.00 feet; thence North 45 degrees 51 minutes 58 seconds East a distance of 100.00 feet to the point of beginning for line to be described; thence North 49 degrees 50 minutes 18 seconds West, a distance of 1000.00 feet and said line there terminating.

Based upon a review of the Ordinance, the Chief Administrative Law Judge makes the following:

ORDER

1. Pursuant to Minn. Stat. § 414.033 (2018), the Ordinance is deemed adequate in all legal respects and properly supports this Order.

2. Pursuant to the terms of the Ordinance and this Order, the Property is **ANNEXED** to the City.

3. As there is no taxable property within the Property, the provisions of Minn. Stat. § 414.036 (2018) are not applicable.

4. The City must file a copy of the Annexation Ordinance with the Township, the appropriate county auditor(s), and the Secretary of State as required by Minn. Stat. § 414.033, subd. 7.
