

NOTICE OF INTENT FOR ANNEXATION

IN THE MATTER OF THE NOTICE OF INTENT FOR THE ANNEXATION OF CERTAIN LAND TO THE CITY OF GLENWOOD, MINNESOTA PURSUANT TO MINNESOTA STATUTES § 414.033, SUBD. 3

TO: Glenwood Town Board, Glenwood Township, Pope County, Minnesota and

Office of Administrative Hearings Municipal Boundary Adjustment Unit P. O. Box 64620 St. Paul, MN 55164-0620

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city, and

WHEREAS, the area proposed for annexation is 40 acres or less in size, is 60% or more bordered by land already within the corporate limits of the City of Glenwood, and is not appropriate for annexation by ordinance pursuant to Minnesota Statutes § 414.033, Subd. 2(3); and

WHEREAS, the area proposed for annexation is described as follows:

SEE "EXHIBIT A" ATTACHED HERETO AND MADE A PART HEREOF

- WHEREAS, the area proposed for annexation abuts upon the corporate limits of the City of Glenwood, Minnesota; and
- WHEREAS, the area proposed for annexation is unincorporated, abuts the city's Easterly boundary, and is not included within any other municipality; and
- WHEREAS, the area proposed for annexation is approximately 26 acres in size; and
- WHEREAS, the reason for the proposed annexation is that the perimeter of the area to be annexed is sixty percent (60%) or more bordered by the municipality and is 40 acres or less; and
- WHEREAS, the nature of the area proposed for annexation is of commercial nature; and
- WHEREAS, the area proposed for annexation is not included in any area that has already been designated for orderly annexation pursuant to Minnesota Statutes § 414.0325, nor in any other proceeding currently pending before the Office of Administrative Hearings Municipal Boundary Adjustment Unit;

NOW THEREFORE, BE IT RESOLVED, BY THE CITY COMMISSION OF GLENWOOD, MINNESOTA that the area described in the attached "Exhibit A" shall be annexed by the City of Glenwood pursuant to the provisions of Section 414.033, Subd. 3, Minnesota Statutes Annotated, and that Notice of Intent to annex such property shall be served upon the Town Board of Glenwood Township, Pope County, Minnesota and upon the Municipal Boundary Adjustment Unit of the Minnesota Office of Administrative Hearings.

"Exhibit A" Tract One: Parcel No.09-0316-001

That part of the Northeast Quarter (NE1/4) Section 18, Township 125, Range 37 described as follows:

Commencing at the Northeast corner of said quarter section;

thence West along the North line of said quarter section 1741.4 feet;

thence South 820 feet;

thence East 1741.4 feet to the East line of said quarter section;
