

## **ORDINANCE NO. 731**

An Ordinance of the City of Cambridge, Minnesota Annexing Land Located in Cambridge Township, Isanti County, Minnesota Pursuant to Minnesota Statutes § 414.033 Subdivision 2 (1), Permitting Annexation by Ordinance

WHEREAS, said property is unincorporated, abuts the City of Cambridge city limits, is owned by the City of Cambridge; and

**NOW, THEREFORE,** THE CITY COUNCIL OF THE CITY OF CAMBRIDGE HEREBY ORDAINS AS FOLLOWS:

- 1. The City Council hereby determines that the property as hereinafter described is owned by the City of Cambridge and the City of Cambridge Economic Development Authority. The Cambridge Economic Development Authority is a department of the City and falls under the City's federal tax identification number.
- 2. None of the property is now included within the limits of any city, or in any area that has already been designated for orderly annexation pursuant to Minnesota Statute § 414.0325.
- 3. The corporate limits of the City of Cambridge, Minnesota, are hereby extended to include the property described as:

- 4. That the area legally described will not increase the population of the City since the land is vacant.
- 5. That pursuant to Minnesota Statutes § 414.036 there are no special assessments assigned by the Town to the annexed property and the City of Cambridge shall pay no property tax reimbursement for these parcels since they are tax exempt (Minnesota Statutes §414.036).
- 6. That the City Administrator of the City of Cambridge is hereby authorized and directed to file a copy of this Ordinance with the Municipal Boundary Adjustment Unit of the Office of Administrative Hearings, the Minnesota Secretary of State, the Isanti County Auditor, and the Cambridge Township Clerk.
- 7. That there will be no change in cost of electric utility service to the property upon annexation.
- 8. That this Ordinance shall be in full force and effect and final upon the date this Ordinance is approved by the Office of Administrative Hearings.




