The North Half of the Southeast Quarter, Section 29, Township 121, Range 27 containing 80 acres or more or less.

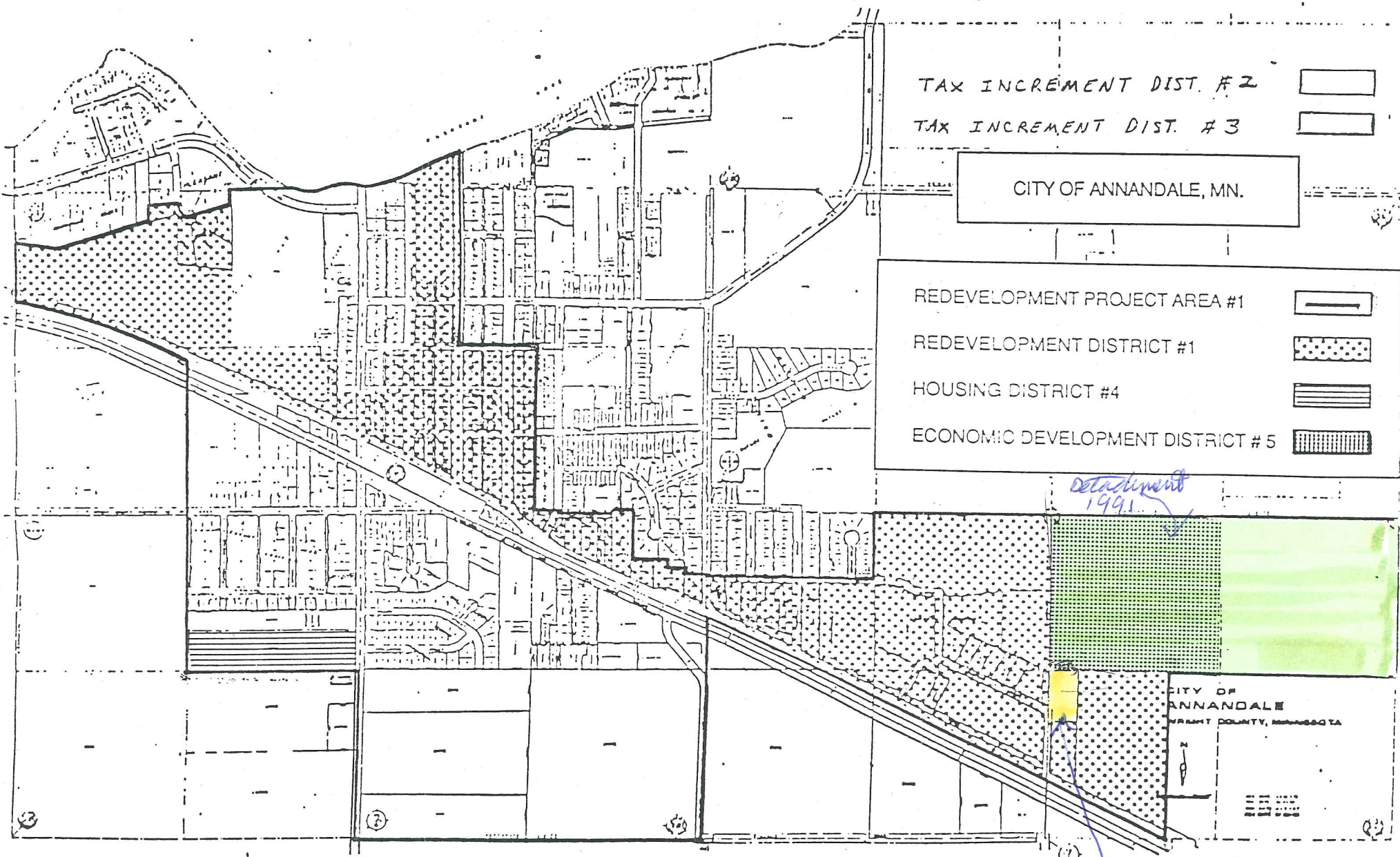
NOW THEREFORE, BE IT RESOLVED that the City Council of Annandale, Minnesota does hereby adopt this resolution and authorize the action stated herein.
