IN THE MATTER OF THE JOINT RESOLUTION OF THE CITY OF BETHEL AND THE TOWN OF ST. FRANCIS DESIGNATING CONCURRENT DETACHMENT AN ANNEXATION OF INCORPORATED LAND AND CONFERRING JURISDICTION OVER SAID AREA TO THE MINNESOTA MUNICIPAL BOARD PURSUANT TO MINNESOTA STATUTES §414.061.

JOINT RESOLUTION FOR ORDERLY ANNEXATION

The CITY OF BETHEL and the CITY OF ST. FRANCIS, Anoka County, Minnesota, hereby jointly agree to the following:

- 1. That the following described area in ST. FRANCIS abuts BETHEL and is currenty not served by municipal services, including no access roads, and contains NO residents, and is therefore appropriate for concurrent detachment and from ST. FRANCIS and annexation into BETHEL, pursuant to §414.061.
- 2. The parties hereto designate the following described area for detachment and annexation, to-wit:

All that part of the North Half of the North Half of the Southeast Quarter of the Northeast Quarter of Section 36, Township 34, Range 24, Anoka County, Minnesota, that is lying and being West of the Burlington Northern Railway Right Of Way, subject to easements of record.

- 3. That the City Council of the BETHEL and the City Council of the ST. FRANCIS, upon adoption and passage of this Resolution and upon the acceptance by the Municipal Board, confirm jurisdiction upon the Municipal Board over the various provisions in this agreement.
- 4. That the property above-described, the area designated for detachment and annexation, abuts BETHEL, is being purchased by BETHEL for use in conjunction with the sewage treatment facility currently being planned.
- 5. That BETHEL is capable of providing services to this area.
- 6. That immediate detachment and annexation is in the best interests of the area proposed for annexation.
- 7. That BETHEL and ST. FRANCIS agree that no alteration of the stated boundaries of this agreement is appropriate.
- 8. That BETHEL and ST. FRANCIS agree that pursuant to Minnesota Statutes §414.061, Subd. 2, no consideration by the Municipal Board is necessary.

UPON RECEIPT OF THIS RESOLUTION, PASSED AND ADOPTED BY EACH PARTY, THE MUNICIPAL BOARD MAY REVIEW AND COMMENT, BUT SHALL, ORDER THE DETACHMENT AND ANNEXATION IN ACCORDANCE WITH THE TERMS OF THIS JOINT RESOLUTION.


