Thence northwesterly on and along the easterly Right of Way of St. Francis Boulevard (State Hwy. #47), as platted in 1959, to its intersection with the southerly boundary of Anoka County Highway Right of Way Plat No. 32. Thence southwesterly on and along the said southerly boundary to the intersection with the easterly boundary of Anoka County Highway Right of Way Plat No. 36 and the point of beginning.

Thence continuing southwesterly on the previous course to the intersection with the southerly line of said Plat No. 36. Thence on and along the southerly line of said Plat No. 36 to the southeast corner of the said Plat.
