
**WHEREAS**, the City of Inver Grove Heights desires to detach a parcel of property approximately one (1) acre in size and legally described as follows:


Lots 1, 2, 3, and 4, Auditor's Subdivision #43, lying W of STH

WHEREAS, the City of Inver Grove Heights desires to detach a parcel of property approximately 1.00 acres in size legally described as follows:

Lots 1, 2, 3, and 4, Auditor's Subdivision #43, lying W of STH #3, all in Section 30, Township 27, Range 22.

WHEREAS, Parcel #1 abuts the City of Eagan and the City of Eagan desires to annex said property; and

WHEREAS, the City of Inver Grove Heights desires to annex a parcel of property approximately 1.20 acres in size and legally described as follows:

That part of the east 1/2 of the southeast 1/4 of Section 24, T27N, R23W, Dakota County, Minnesota, lying easterly of the east right-of-way line of Trunk Highway #3 (South Robert Trail), and herein referred to as "Parcel #2"; and

WHEREAS, Parcel #2 abuts the City of Inver Grove Heights and the City of Inver Grove Heights desires to annex said property.

NOW, THEREFORE, BE IT RESOLVED, THAT THE CITY COUNCIL OF THE CITY OF INVER GROVE HEIGHTS hereby approves the concurrent detachment of Parcel #1 from the City of Inver Grove Heights and annexation of Parcel #1 to the City of Eagan, providing that the City of Eagan approves the concurrent detachment of Parcel #2 from the City of Eagan and the annexation of Parcel #2 to the City of Inver Grove Heights; and

NOW, THEREFORE, BE IT FURTHER RESOLVED, that subject to the condition above, the City of Inver Grove Heights, in conjunction with the City of Eagan, shall submit the concurrent detachments/annexations to the Minnesota Municipal Board with the intent and request that the Municipal Board order both concurrent detachments and annexations.

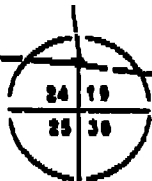
