**JOINT RESOLUTION BETWEEN THE CITY OF ANOKA AND THE  
CITY OF COON RAPIDS FOR THE CONCURRENT DETACHMENT AND  
ANNEXATION OF INCORPORATED LAND PURSUANT TO  
MINNESOTA STATUTES SECTION 414.061**

**WHEREAS,** the following described property is located within the corporate limits of the City of Coon Rapids, Anoka County, Minnesota (see also Exhibit A):

That part of the NW 1/4 of the NW 1/4 and the SW 1/4 of the NW 1/4 of Section 5, Township 31, Range 24, in the City of Coon Rapids, Anoka County, Minnesota, more particularly described as follows:

Commencing at the northeast corner on the said NW 1/4 of the NW 1/4 of Section 5; thence southerly along the easterly line of the said NW 1/4 of the NW 1/4 a distance of 400 feet; thence continuing on a line deflecting to the right at an angle of 45 degrees, 00 minutes, 00 seconds to its intersection with a line parallel to and 750 feet easterly of the westerly line of said NW 1/4 of the NW 1/4 of Section 5; thence continuing southerly on said parallel line a distance of 1,000 feet; thence continuing on a line deflecting to the right 45 degrees, 00 minutes, 00 seconds, to its intersection with the East line of the West 1/2 of the said SW 1/4 of the NW 1/4 of Section 5; thence continuing southerly on said easterly line to its intersection with the South line of said SW 1/4 of the NW 1/4; thence westerly along the South line of said SW 1/4 of the NW 1/4 to the southwest corner thereof; thence northerly along the westerly line of the NW 1/4 of said Section 5; to the northwest corner thereof; thence easterly along the North line of said NW 1/4 of the NW 1/4 to the point of commencement.

**WHEREAS,** said property abuts the City of Anoka, Anoka County, Minnesota and is owned by the City of Anoka; and

**WHEREAS,** said property is undeveloped; and

**WHEREAS,** said property can be more practically served by public utilities from the City of Anoka than from the City of Coon Rapids; and

That this joint resolution of the City of Anoka and the City of Coon Rapids shall be submitted to the Minnesota Municipal Board with the intent and request that the Municipal Board concurrently detach the above described property from the City of Coon Rapids and annex the same to the City of Anoka at the earliest possible date.

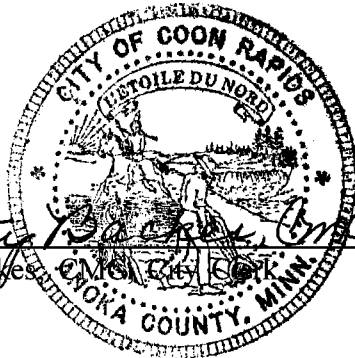
NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Anoka, County of Anoka, State of Minnesota, as follows:

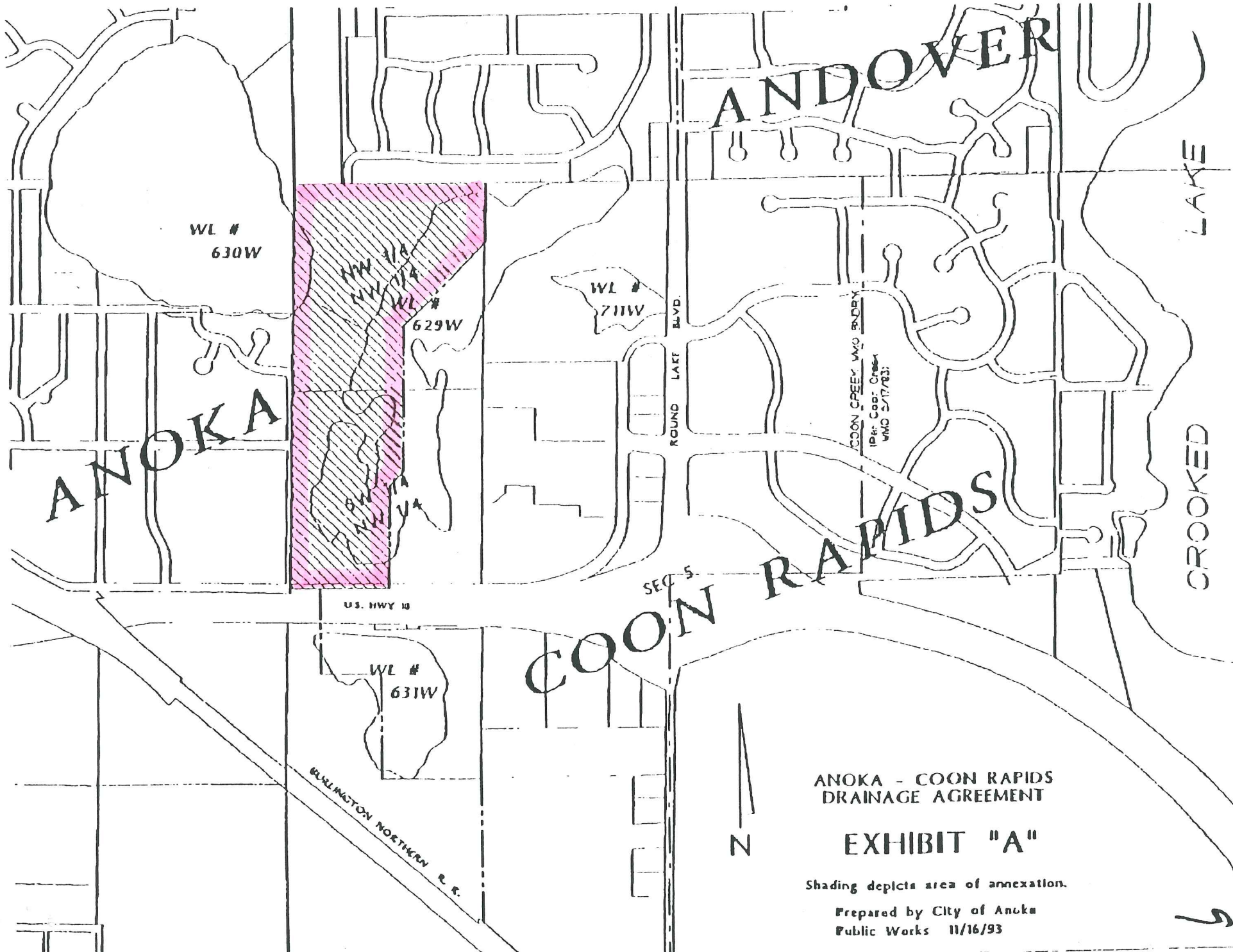
