ANNEXATION TO THE CITY OF ST. BONIFACIUS) CONCLUSIONS OF LAW
PURSUANT TO MINNESOTA STATUTES 414) AND ORDER

On February 8, 1996, the Minnesota Municipal Board received a petition by Gerald and Cynthia Weinzierl, all of the property owners, with a supporting resolution from the City of St. Bonifacius, which requested the detachment of certain property from the City of Minnetrista and annexation of the same territory to the City of St. Bonifacius pursuant to Minnesota Statutes 414.061.

On February, 8, 1996, the Minnesota Municipal Board received the Resolution No. 114-95 from the City of Minnetrista denying the request for concurrent detachment and annexation of the Weinzierl property.

On March 19, 1996, the Minnesota Municipal Board received Resolution No. 30-96 from the City of Minnetrista rescinding Resolution No. 114-95 and supporting the concurrent detachment and annexation of the Weinzierl property.

After review of the petition and resolutions, the Minnesota Municipal Board hereby makes and files the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

1. That a petition requesting concurrent detachment and annexation of certain property was received by all of the property owners.

2. That supporting resolutions from the Cities of Minnetrista and St. Bonifacius were received.

3. The petition contained all the information required by statute including a description of the territory proposed for detachment and annexation, which is as follows:

Commencing at the Northeast corner of the Northwest 1/4, Section 31, Township 117 North, Range 24 West, then West 120 feet then South 114 feet to the Northerly line of State Highway 7 then Southeasterly along said Highway line to the East line of the Northwest 1/4 then North 168 feet to beginning.

4. The area proposed for detachment and annexation is situated within the City of Minnetrista and abuts the municipal boundary of the City of St. Bonifacius.

CONCLUSIONS OF LAW

1. The Minnesota Municipal Board duly acquired and now has jurisdiction of the within proceeding.

2. An order should be issued by the Minnesota Municipal Board concurrently detaching and annexing the area described herein.

O R D E R

1. IT IS HEREBY ORDERED: That the property described in Findings of Fact 3 be, and the same hereby is, detached from the City of Minnetrista and annexed to the City of St. Bonifacius, the same as if it had originally been made a part thereof.

2. IT IS FURTHER ORDERED: That the population of the City of St. Bonifacius is hereby increased by 4.

3. IT IS FURTHER ORDERED: That the population of the City of Minnetrista is hereby decreased by 4.

4. IT IS FURTHER ORDERED: That the effective date of this order is March 20, 1996.

5. IT IS FURTHER ORDERED: That the effective date of this amended order is April 9, 1996.
