Notice is hereby given that a public hearing will be held pursuant to Minnesota Statutes 414, as amended, before the Director of the Office of Strategic and Long Range Planning, or his designee, in the above-entitled matter.

The hearing will convene at 9:00 a.m. on the 6th day of July, 1999, in the Council Chambers of Oak Grove City Hall, 19900 Nightingale Street N.W., Oak Grove, Minnesota, and be immediately continued indefinitely. All persons shall be given an opportunity to be heard orally and to submit written data, statements or arguments concerning the above-entitled matter. The right to testify and the admission of testimony and other evidence shall be governed by the Rules of the Minnesota Municipal Board. The property proposed for detachment and annexation is described as follows:

The northwest quarter (NW 1/4) of the southwest quarter (SW 1/4), exempt the south 300 feet of the west 726 feet of section 4, Town 33N, Range 24W and the


northeast quarter of the southwest quarter (SW 1/4) of section 4, Town 33N, Range 24W and the northwest quarter (NW 1/4) of section 4, Town 33N, Range 24W, except the north 264 feet of the west 330 feet thereof and the west one-half (W 1/2) of the northeast quarter (NE 1/4), Section 4, Town 33N, Range 20W and the northeast quarter (NE 1/4) of the southeast 1/4 of Section 4, Town 33, Range 20W together with all easements appurtenant thereto and the northwest quarter (NW 1/4) of the southeast quarter (SE 1/4) of Section 4, Town 33, Range 24W and the southwest quarter (SW 1/4) of the southeast quarter (SE 1/4) of section 4, Town 33N, Range 24W. Approximately 412 acres located in the City of Oak Grove, Anoka County, Minnesota.

After all testimony is complete and the record is closed, the Director of the Office of Strategic and Long Range Planning, or his designee, will issue its findings and order in accordance with Minnesota Statutes Chapter 414.
