Notice is hereby given that a public hearing will be held pursuant to Minnesota Statutes 414, as amended, before the Director of the Office of Strategic and Long Range Planning, or designee, in the above-entitled matter.

The hearing will convene at 9:00 a.m. on the 21ST day of July, 1999, in Dundas City Hall on Railway Street, Dundas, Minnesota, and be immediately continued indefinitely. All persons shall be given an opportunity to be heard orally and to submit written data, statements or arguments concerning the above-entitled matter. The right to testify and the admission of testimony and other evidence shall be governed by the Rules of the Minnesota Municipal Board. The property proposed for detachment is described as follows:
