On March 16, 2001, the Office of Strategic and Long Range Planning received resolutions from the Cities of Inver Grove Heights and So. St. Paul, requesting the detachment of certain property from the City of Inver Grove Heights and annexation of the same property to the City of So. St. Paul pursuant to Minnesota Statutes 414.061.

After review of the resolution, the Director of the Office of Strategic and Long
Range Planning hereby makes and files the following Findings of Fact, Conclusions of
Law, and Order.

FINDINGS OF FACT

- 1. That resolutions requesting concurrent detachment and annexation of certain property were received from the Cities of Inver Grove Heights and So. St. Paul.
- 2. The resolutions contained all the information required by statute including a description of the territory proposed for concurrent detachment and annexation, which is as follows:

The east one-half of the platted alley lying northerly of the North line of Lot 12 extended westerly within Block 1, Sarles' Addition to South St. Paul,

Dakota County, Minnesota (0.107 acres).

3. The area proposed for concurrent detachment and annexation is situated within the City of Inver Grove Heights and abuts the municipal boundary of the City of So. St. Paul.

CONCLUSIONS OF LAW

- 1. The Office of Strategic and Long Range Planning has duly acquired and now has jurisdiction of the within proceeding.
- 2. An order should be issued by the Director of the Office of Strategic and Long Range Planning concurrently detaching and annexing the area described herein.

ORDER

- 1. IT IS HEREBY ORDERED: That the property described in Findings of Fact 2 be, and the same hereby is, detached from the City of Inver Grove Heights and annexed to the City of So. St. Paul, the same as if it had originally been made a part thereof.
- 2. IT IS FURTHER ORDERED: That the effective date of this order is March 16, 2001.
