DETACHMENT OF PROPERTY IN THE CITY OF MADISON, MINNESOTA.**

Charles A. Wright, III, a single person, and Jacki A. Freiberg, a single person, joint life tenants, and Rose M. Neal, as trustee of the Charles A. Wright, III, and Jacki A. Freiberg A. Freiberg Irrevocable Trust Agreement dated July 31, 2000, (remainder tenant), the undersigned and 100% owners of the property described below, hereby petition the City Council of the City of Madison to detach said property from the City of Madison, Minnesota, and for that purpose respectfully states:

1. That petitioners are the sole property owners of the property described to be detached from the City of Madison;
2. The property to be detached is legally described as follows:

That part of the Northwest Quarter (NW ¼), Section Twenty-eight (28), Township One Hundred Eighteen (118) North, of Range Forty-four (44) West lying south of the Lac qui Parle Railroad Authority property less the south 80 acres thereof, said tract consisting of 40.75 acres, more or less.

3. The property is rural in character;
4. There are no city utilities or improvements to the above-described property;
5. There has been no development for urban residential, commercial, or industrial purposes;
6. There are no residences located upon the property;
7. The property constitutes 40.75 acres more or less; and
8. Said property is contiguous to the City of Madison on its north boundary only, and is contiguous to Madison Township property on all other sides.

2. That pursuant to Minn.Stat.§414.06, the proposed detachment is hereby supported.






