A RESOLUTION OF THE CITY OF BEMIDJI FOR DETACHMENT OF CERTAIN LAND PURSUANT TO M.S. 414.06

(Thomas Sorenson Property)

WHEREAS, the property described below is presently within the corporate limits of the City of Bemidji, abuts the municipal's northeast boundary and the boundary of the Township of Bemidji, in the County of Beltrami; and

WHEREAS, this property proposed for detachment is rural in character and not developed for urban residential, commercial, or industrial purposes; and

WHEREAS, the property proposed for detachment is 40 acres and is described as follows:

Legal Description: (Tax Parcel #R80.00266.00) - The Southeast one-quarter (SE ¼) of the Northeast one-quarter (NE ¼) of Section 12, Township 146 N, Range 33 W. A total of 40-acres.

WHEREAS, the sole property owner has requested that the City consider detachment of this property from the City's corporate limits, and has submitted a Petition for Detachment; and

WHEREAS, there are no buildings or public improvements on said property and the number of residents in the area proposed for detachment is zero; and
