On August 19, 2003, Municipal Boundary Adjustments received resolutions from the Cities of Albertville and St. Michael, requesting the concurrent detachment and annexation of certain properties between the two cities pursuant to Minnesota Statutes 414.061.

After review of the resolutions, the Acting Director hereby makes and files the following Findings of Fact, Conclusions of Law, and Order.

#### FINDINGS OF FACT

1. That a resolution requesting concurrent detachment and annexation of certain

properties was received from the Cities of Albertville and St. Michael.

2. The resolution contained all the information required by statute including a

description of the territory proposed for concurrent detachment and annexation, which is as

follows:

The western 89.84 feet of that part of the NE  $\frac{1}{4}$  described as commencing at the north  $\frac{1}{4}$  corner of SD Section 12 thence east 1224 feet for point of beginning, thence continuing  $\frac{5}{5}$  east 165 feet thence of def R89D39' 264 feet thence west 164 feet thence north 264 feet

to point of beginning. All in Section 12, Township 120, Range 24, Wright County, Minnesota. 101-500-121202.

3. The area proposed for concurrent detachment and annexation is situated within the Cities of Albertville and St. Michael and abut the municipal boundaries of said cities.

4. On October 13, 2003, the Acting Director reviewed the resolutions and all pertinent information contained in the files for concurrent detachment and annexation.

#### CONCLUSIONS OF LAW

1. The Department of Administration has duly acquired and now has jurisdiction of the within proceedings.

2. An order should be issued by the Acting Director concurrently detaching and

annexing the area described herein.

### <u>ORDER</u>

1. IT IS HEREBY ORDERED: That the property described in Findings of Fact 2 be,

and the same hereby is, detached from the City of Albertville and annexed to the City of St.

Michael, the same as if it had originally been made a part thereof.
