That part of the Southeast Quarter of the Northwest Quarter of Section 1 Township 108 North Range 27 West, described as:

Commencing at the Center of Section 1 Township 108 North Range 27 West; thence South 88 degrees 32 minutes 10 seconds West, (assumed bearing) along the east - west center line of Section 1, a distance of 268.75 feet to the point of intersection with a line drawn parallel with and distant 170.00 feet easterly of, as measured at right angle to, the center line of Lake Street, as now laid out and traveled; said point being the point of beginning; thence North 00 degrees 30 minutes 58 seconds East, along a line parallel with and distant 170.00 feet easterly of, as measured at right angle to, said Lake Street center line, a distance of 340.20 feet to a point on the north line of the South 340.00 feet of the Southeast Quarter of the Northwest Quarter of Section 1; thence North 88 degrees 32 minutes 10 seconds East, along said north line, 48.34 feet to the center line of a buried metal culvert; thence North 08 degrees 33 minutes 05 seconds East, along the center line of a buried metal and concrete culvert, 94.52 feet; thence North 89 degrees 29 minutes 02 seconds West, 61.53 feet to the point of intersection with a line which bears North 00 degrees 30 minutes 58 seconds East, from the point of beginning; thence North 00

degrees 30 minutes 58 seconds East, 99.44 feet to the point of intersection with the center line of the Old Minnesota River Channel as witnessed by the Resurvey of the Right and Left Bank Government Meanders, thence South 18 degrees 25 minutes 00 seconds West, along said Old Minnesota River Channel center line, 157.31 feet; thence South 09 degrees 54 minutes 22 seconds West, along said Minnesota River Channel center line, 346.40 feet; thence South 00 degrees 03 minutes 40 seconds East, along said Minnesota River Channel center line, 47.07 feet to the point of intersection with the east - west center line of Section 1; thence North 88 degrees 32 minutes 10 seconds East, 104.46 feet to the point of beginning.
