- 1. That the Petitioners are the sole owners in fee title of a parcel of land comprising approximately 406 acres of land abutting the northerly municipal boundary of the City of Coleraine and being located entirely within the municipal boundary of the City of Coleraine, said land being more specifically described on Exhibit "A" attached hereto and made a part hereof.
- 2. That the entire parcel of land owned by the Petitioners is rural in character and is vacant and unoccupied.
- 3. That the entire parcel of land owned by the Petitioners contains no existing structures, buildings, residences or municipal improvements, except a storage building and hunting shed (mobile home).
- 4. That the Petitioners believe that the detachment of their property from the City of Coleraine would not unreasonably affect the symmetry of the boundaries of the City of Coleraine and that the property owned by the Petitioners is not needed by the City of Coleraine for any anticipated future development.

5. That all real estate taxes due and payable in the year 2003 and all prior years on the parcel of land owned by the Petitioners have been paid in full.
