PURSUANT TO MINNESOTA STATUTES 414)	AND ORDER

WHEREAS, on June 29, 2005, Municipal Boundary Adjustments received a petition for the detachment of certain land from the City of Lanesboro and City Resolution supporting the petition for detachment; and

WHEREAS, Reorganization Order No. 192, effective March 8, 2005, has transferred the duties of the Director to the Chief Administrative Law Judge; and

After review of the petition and resolution, the Chief Administrative Law Judge hereby makes and files the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

- 1. That a petition and resolution were duly filed with the Office of Administrative Hearings-Municipal Boundary Adjustments for the detachment of property from the City of Lanesboro.
- 2. The petition and resolution contained all the information required by statute including a description of the territory proposed for detachment, which is as follows:

That part of the West Half of the Northwest Quarter of Section 18, Township 103 North, Range 9 West, Fillmore County, Minnesota, described as follows:

Commencing at the southwest corner of the Northwest Quarter of said Section 18; thence North 00 degrees 09 minutes 43 seconds West (Note: all bearings are in relationship with the west line of said

Northwest Quarter) along the west line of said Northwest Quarter for a distance of 948.38 feet; thence North 89 degrees 50 minutes 17 seconds East a distance of 518.97 feet to the POINT OF BEGINNING: thence North 00 degrees 09 minutes 43 seconds West a distance of 775.00 feet; thence North 89 degrees 50 minutes 17 seconds East a distance of 281.03 feet; thence South 00 degrees 09 minutes 43 seconds East a distance of 775.00 feet; thence South 89 degrees 50 minutes 17 seconds West a distance of 281.03 feet to the POINT OF BEGINNING.

Said Parcel contains 5.00 acres, more or less.

- 3. The area proposed for detachment is situated within the City of Lanesboro and abuts the municipal boundary.
 - 4. The area proposed for detachment is approximately 5 acres.
- 5. The area proposed for detachment is rural in character and not developed for urban residential, commercial, or industrial purposes.
- 6. There are no municipal improvements needed on the area proposed for detachment.
 - 7. The area abuts the Town of Holt, Fillmore County.

CONCLUSIONS OF LAW

- 1. The Office of Administrative Hearings has duly acquired and now has jurisdiction of the within proceeding.
- 2. An order should be issued by the Chief Administrative Law Judge detaching the area described herein.

ORDER

1. IT IS HEREBY ORDERED: That the property described in Findings of Fact 2 be, and the same hereby is, detached from the City of Lanesboro and made a part of the Town of

Holt, the same as if it had originally been made a part thereof.
