On September 7, 2010 the Chief Administrative Law Judge, through his designee, invoked the authority under Minnesota Statutes Section 414.01, subd. 16, requiring the petitioners and the local units of government to meet to discuss the possible resolution of contested issues in the matter.


The petitioners, the City of Princeton, and Princeton Township are directed to meet at least three times over the next 60 days to discuss resolution of issues raised by the petition and other issues of mutual concern.

The parties shall designate a person to report the results of such meetings to the Executive Director of Municipal Boundary Adjustments at the conclusion of the time period. The time frame for these discussions shall begin immediately and conclude by Monday, November 8, 2010.
