IN THE MATTER OF THE PETITIONS OF THE VILLAGE OF LONG LAKE
AND THE VILLAGE OF ORONO FOR THE SIMULTANEOUS DETACHMENT
AND ANNEXATION OF CERTAIN PROPERTY UNDER CHAPTER 686, MINN-
ESOTA LAWS 1959, AS AMENDED BY LAWS 1963, CHAPTERS 807 & 621

O R D E R

The Village of Long Lake, by resolution of the village council at an official meeting held October 20, 1964, petitioned for the annexation of certain property and the Village of Orono has concurrently, by resolution of the village council at an official meeting held on October 12, 1964, petitioned to detach the same territory, pursuant to Chap. 686, Minn. Laws 1959, Section 6 as amended by Laws 1963, Chap 807 and 621.

The territory involved consists of:

That part of the Southeast quarter of Sec. 34, Twp. 118 North, R. 23 West of the 5th Principal Meridian, described as follows: Beginning at a point on the West line of said quarter section 11.36 chains north of the southwest corner thereof; thence north $74\frac{1}{2}$ degrees east 119.14 feet; thence south parallel with the west line of said quarter section, 184.14 feet; thence south $74\frac{1}{2}$ degrees west 119.14 feet to the west line of said quarter section; thence north 184.14 feet to the point of beginning;

That part of the southeast quarter of Sec. 34, T. 118, north, Range 23 west, described as follows: Commencing at a point on the west line of said quarter section, 11.36 chains north of the southwest corner thereof; thence north $74\frac{1}{2}$ degrees east onto 119.14 feet to actual point of beginning of tract of land to be described; thence continuing north $74\frac{1}{2}$ degrees east 85 feet; thence south parallel with the west line of said quarter section 184.14 feet; thence south $74\frac{1}{2}$ degrees west 85 feet; thence north 184.14 feet to the actual point of beginning

All the requirements of the statute having been met,

IT IS ORDERED: That the above described real property be and is hereby detached from the Village of Orono and annexed to the Village of Long Lake, the same as if it had originally been a part thereof.
