PETITIONERS STATE: The number of petitioners required by Minnesota Statutes § 414.06, Subd. 1, to commence this proceeding is: all of the property owners if the area is less than 40 acres; or 75% or more of the property owners in number if the area is more than 40 acres.

It is hereby requested by:

 all of the property owners, the area is less than 40 acres; or
 X 75% or more of the property owners, the area is more than 40 acres;
to detach certain properties described herein from the City of Babbitt and make
it St. Louis County Unorganized

1. There are 194 property owners in the area proposed for detachment.
2. 150 property owners have signed this petition. (If the land is owned by both the husband and wife, both must sign the petition to represent all owners.)
3. The property is situated within the City of Babbitt , abuts the municipal boundary, and is located in the County of St. Louis .
The petitioned area abuts on the city's N S E (W)(circle one) boundary(ies).
4. The property proposed for detachment is rural in character and not developed for urban residential, commercial, or industrial purposes.
5. The number of acres in the property proposed for detachment is approximately 5675 and is described as follows: **Sections 4, 5, 6, 7, 8, 9, 17, 18, 19 T. 60N - R.13W.**

6. The reason detachment is requested is because the City of Babbitt does not provide the "Rural" residents the amenities that the "In Town" residents of Babbitt receive. For example they do NOT provide water, sewer, sidewalks, street lights, bike paths or road maintenance. The "Rural" residents pay the same percentage of their taxes to the City of Babbitt as the "In Town" residents do.
7. The number of residents in the area proposed for detachment is 115 (not including dependants).
