**NOTICE OF RECONVENED HEARING**

The evidentiary hearing concerning this Petition will reconvene on July 29, 2013, beginning at 9:00 a.m. at the Gilbert City Hall, Council Chambers, 16 South Broadway, Gilbert, Minnesota before Administrative Law Judge Amy J. Chantry. This is a continuation of the first hearing in this matter held on August 30, 2012 and reconvened on May 2, 2013.

The only formal parties to this proceeding to date are the Petitioners, City of Gilbert, and Fayal Township. The Petitioners have petitioned the State for authority to detach certain land.

The hearing will be conducted pursuant to the procedure set out in Minnesota Rules, Chapter 6000 as supplemented by Minnesota Rules 14.57 - 14.62.
