## Gentlemen:

Pursuant to Minn. Stat. § 414.06, Subd. 2, the Chief Administrative Law Judge, through his designee has ordered the parties to participate in a mediation session. The parties have the option of:

- (1) Either jointly agreeing on a mediator of their choosing to conduct the mediation process; or
- (2) Entering into a mediation agreement with the Office of Administrative Hearings, pursuant to Minn. Stat. Sec. 414.12, authorizing the Chief Administrative Law Judge to appoint an administrative law judge to conduct the mediation process.

The parties must notify the Municipal Boundary Adjustment Unit (MBAU) no later than Monday, November 19, 2012, as to which option they choose. If the parties are unable to agree on either of these two options, the Chief Administrative Law Judge will assign a mediator. The assignment of a mediator will occur by December 4, 2012.

I have been advised that counsel for the city and petitioners plan to discuss the contested issues on their own in an attempt to resolve this matter prior to mediation or hearing. I wish you well in the effort. If settlement is achieved, please notify the MBAU promptly.
