## **NOTICE OF HEARING**

Notice is hereby given that a public hearing will be held pursuant to Minnesota Statutes 414, as amended, before the Chief Administrative Law Judge, in the aboveentitled matter.

The first hearing will convene at 9:00 a.m. on May 24, 2013, in the Council Chambers at the Lake Benton City Hall, 106 S. Center Street, Lake Benton, MN 56149. The evidentiary part of the hearing will be continued to an indefinite date. All persons shall be given an opportunity to be heard orally and to submit written data, statements, or arguments concerning the above-entitled matter when this hearing is reconvened by an administrative law judge. The right to testify and the admission of testimony and other evidence shall be governed by the Rules of the Office of Administrative Hearings, Municipal Boundary Adjustments, Chapter 6000 and any other Statutes or rules that may be applicable.

The property proposed for detachment is described as follows:

The East Half of the Northwest Quarter (E½NW¼) also Government Lots Numbered One (1), Two (2), Three (3) and Four (4) also the East Half of the Southwest Quarter (E½SW¼) all of Section Numbered Seven (7) in Township Numbered One Hundred Nine (109) North of Range Numbered Forty-five (45) West of the Fifth (5<sup>th</sup>) Principal Meridian. That part of the W2 of Sec. 7 in Twp, 109N., Range 45 West of the 5<sup>th</sup> P.M. bounded and described as follows, to-wit: Beginning at the center of said Section 7; thence running South 1 degree West 1,323.5 feet; thence
