Section 04 Twp 105 Range 30 Auditor's Sub D Lot 00B 21.97 Acres of Ag land



BASE DATA - 2009



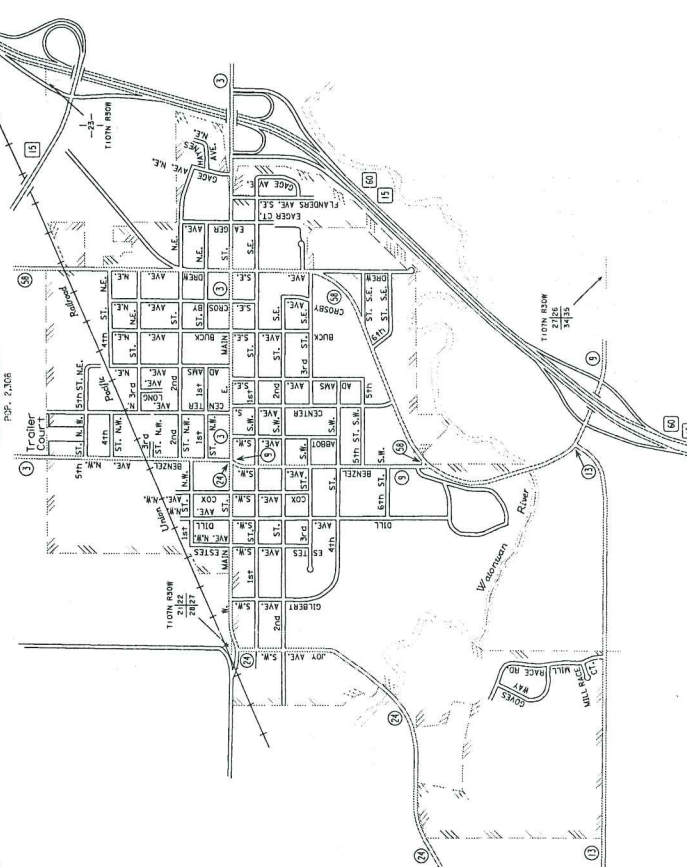

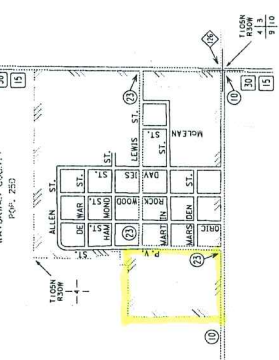

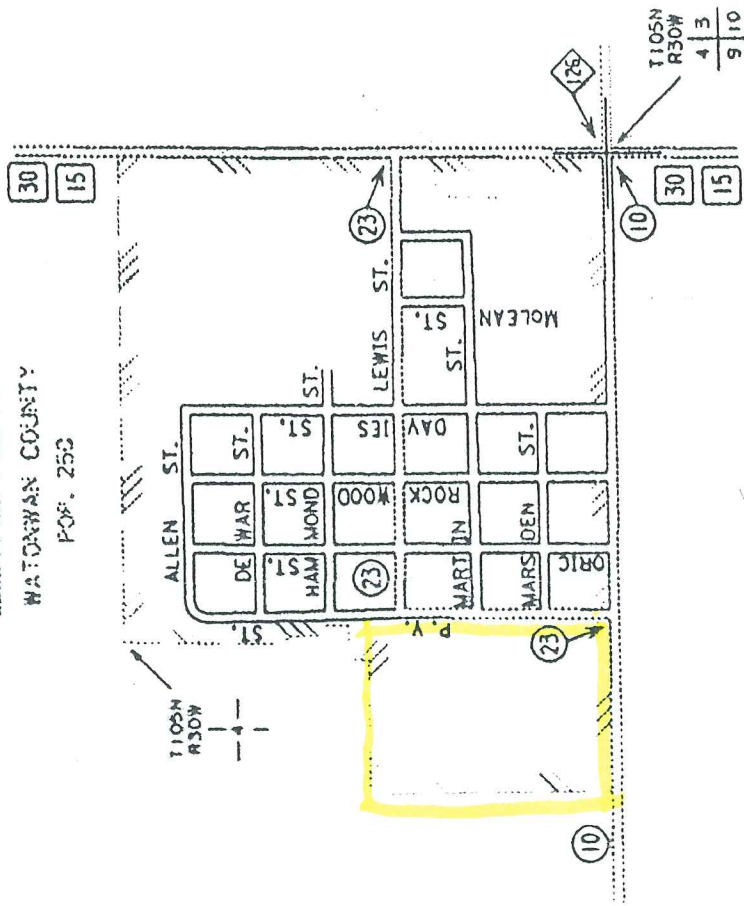
