## Petition of Mary L Schatz for Detachment

#### Parcel 1

Commencing at a point 676 feet west of the east quarter stone of Section No. 9, in Township No. 111, North of Range No. 23, and running thence west 1502 feet to the center line of the county ditch, thence in a northeasterly direction 330 feet, thence east 1406 feet, thence south 330 feet to point of beginning, subject to easements for public streets.

Note: This is the description of a parcel acquired by a Judgment awarding the land to the father of the resent owner by the process of adverse possession June 23 2006.


