The Petitioners have petitioned the state for authority to detach certain real property from the city of Woodstock to Burke Township. ## EXCEPT

A tract located in the Southeast Quarter (SE<sup>1</sup>/<sub>4</sub>) of Section Two (2), Township One-hundred six (106) North, Range Forty-four (44) West of the Fifth P.M., Pipestone County, Minnesota, as follows, to-wit:

Commencing at the southwest quarter corner of said Southeast Quarter (SE¼), thence due North a distance of approximately 514.96 feet to the Point of Beginning of the tract to be described; thence due northerly a distance of 594.00 feet to a point, thence due easterly a distance of 396.00 feet to a point, thence due southerly a distance of approximately 627.00 feet to a point on the north right-of-way line of the C. & St. Paul, Minneapolis & Omaha Railroad, thence westerly along the said north right-of-way line of the C. & St. Paul, Minneapolis & Omaha Railroad, thence westerly along the said north right-of-way line of the C. & St. Paul, Minneapolis & Omaha Railroad a distance of approximately 397.37 feet to the Point of Beginning, containing approximately 5.56 acres more or less;
